DR. CARLA J. EVERS



Dr. Carla J. Evers is the superintendent of education for Pass Christian School District. She previously served as director of instructional programs for the Gulfport School District where she helped lead the effort to implement the state's college and career readiness standards and develop the middle college concept and career academies at Gulfport High School. As part of the Innovative Schools program, this work helped lay the foundation for broader Carnegie unit offerings at middle school, flexible scheduling, and an expansion of dual-credit offerings. Dr. Evers also served as an elementary principal while in Gulfport as well as during her nine-year tenure with the Natchez-Adams School District. During her 27 years as an educator, she earned several honors, including teacher and administrator of the year. She has also served on several

community boards and belonged to service organizations, including the Lynn Meadows Discovery Center Board of Trustees, Head Start Policy Board, executive committee of the Mississippi Gulf Coast Alumnae Chapter of Delta Sigma Theta Sorority, and Rotary Education Committee.






