# **METIS** CONCURRENT SESSION SYNOPSIS:

# ACCESS FOR ALL GUIDE: TEACHING STRATEGIES FOR ALL STUDENTS

Presented by MDE's Teresa Laney from the Office of Exceptional Services. This session is designed to provide participants with an overview of the Access for All Guide. The AFA Guide includes classroom adaptations and teaching strategies for all struggling learners in the general education setting. The goal is to introduce the Access for All Guide to teachers and administrators as a tool for assisting struggling learners in the general education setting.

# BACK TO SCHOOL WITH IREADY AND READY

Presented by Andrea Shane with Curriculum Associates. We will provide an overview of evidence-based best instructional practices to support a blended approach to fill in the skills gaps as well as provide strategies for grade level instruction. We will share guidance for data chats and small group instruction for grades K-8. One key element of a successful implantation is embedding many levels of goal-oriented incentives. We will share ideas and resources that will motivate teachers in their reading and math classrooms. IREADY is not only a K-12 diagnostic, but provides student led and teacher led instruction. IREADY is an approved MDE K-3 screener. The goal is to share many ideas for educators to set their year up for success. We will provide an overview of important information with IREADY and READY.

# CHRONIC ABSENTEEISM: MORE THAN JUST TRUANCY

Presented by MDE's Toni Kersh from the Office of Compulsory School Attendance Enforcement. The session will provide participants with information on what chronic absenteeism is and its impact of student performance. Participants will also be provided with possible solutions and strategies to reduce chronic absenteeism. The goal of the presentation is for participants to leave understanding the definition of chronic absenteeism, how to unpack chronic absenteeism data, and what to do once the data has be disaggregated.

# CURRICULUM AND INSTRUCTION UPDATES & ALGEBRA NATION STATE IMPLEMENTATION

Presented by MDE's Dr. Marla Davis from the Office of Secondary Education. During this session, participants will be provided with an overview of key initiatives from the Office of Secondary Education regarding curriculum, instructional supports, and the state's implementation plan for SY 2019-20 regarding Algebra Nation. The goal is for attendees to learn more about several initiatives from the Office of Secondary Education relative to curriculum and instruction, academics, and professional development.

# DATA DRIVEN COACHING (AMPLIFY)

Presented by Dr. Carolyn McGehee with Amplify. The Amplify data coach program supported one cohort of schools or 5 years and has now completed its first year of support with the second cohort of 7 schools. Data coaches work directly with teachers in PLCs, individual support meetings and classroom visits to increase student achievement. While the data analysis is part of the role of the Amplify coach, the purpose is to analyze data in order to plan effective instruction based on student needs and the rigor of the standards. The presentation shares the program goals and practices with others and explains the lessons learned, best practices used, and outcomes accomplished. The goal of our session is to have teachers and school leaders understand the use of data analysis and what structures can be used within any school to improve student achievement through collaborative efforts of the adults in the school.



# DATA ENTRY FOR DIPLOMA OPTIONS AND END OF COURSE EXAM RESULTS

Presented by Heather Morrison from MS Institutions of Higher Learning. Participants in this session will get a review of the different diploma options available for the upcoming year. There will also be a secondary education web page resources tutorial for up-to-date information, and instructions about how to enter the EOC exam option that students utilize to meet graduation requirements will be included. The goal is to clarify the process for MSIS clerks to enter data when students use EOC exam in-lieu of options, to share current resources for secondary counselors, clerks, and administrators, and to review the diploma options for the upcoming school year.

# DATA ENTRY FOR DISTANCE LEARNING, BLENDED LEARNING, AND ONLINE COURSES

Presented by Heather Morrison from MS Institutions of Higher Learning. This session will highlight the differences in distance learning, blended learning and online courses, as well as instruct participants about how to enter the data into the system. Participants will learn about the changes in the Mississippi Virtual Public School program and the Mississippi Online Course Application process. Issues with the teacher of record for Dual Credit classes will also be reviewed. The goal is to clarify the process for MSIS clerks enter data when the teacher of record is not an employee of the district, and to inform district personnel about the per pupil allotment for online courses through MVPS.

#### DATA SNAPSHOTS: A PICTURE OF SCHOOL IMPROVEMENT

Presented by Deowarski McDonald from the Office of School Improvement Programs. The Office of School Improvement utilizes various data points to gain insight needed to make the best decisions regarding student outcomes. Data also allows us to be intentional with support provided to school leaders and teachers through coaches, professional learning, and other resources. In this session, participants will be guided through the process that is utilized when making decisions based on the collection of data from districts. The goal of this presentation is for participants to gain an understanding of the process that is utilized by the Office of School Improvement when making decisions based on the collection of data from districts.

#### DIGITAL CITIZENSHIP 101

Presented by Eva Harvell with Pascagoula-Gautier School District. You have a firm grasp of the content you teach, but do you have a firm grasp of what it takes to prepare students to become positive digital citizens? Join me as we discuss what digital citizenship is and what it looks like in the classroom and beyond. The learning objective for the presentation is to promote a deeper understanding of digital citizenship and ways to integrate the concept in the classroom and beyond.

Participants will acquire that skills and understanding to access DRC INSIGHT and successfully utilize all the resources available, which will promote successful testing, data reporting, and analysis.

# LITERACY FOR THE 21<sup>ST</sup> CENTURY

This course is a must for any school or districts receiving federal funds and desiring to achieve Accessibility compliance. The objectives for the session are two-fold; 1.) is to increase the attendees' knowledge of Accessibility and how it relates to the law, and 2.) to provide useful tips to aid school personnel in achieving Accessibility compliance.

#### MAKING THE MOST OF YOUR MAC (BYOD)

The Making the Most of Your Mac is a session designed for: 1) those who are new to the Mac platform; and 2) those who have had Mac for a while but want to learn how to get more out of it. #### MANAGING YOUR NETWORK: FACTS AND FICTION

#### QUESTAR ASSESSMENT: NEXTERA ADMIN & TEST DELIVERY UPDATE

Presented by Larry Fruth from Access 4 Learning (A4L - Student Privacy Alliance) and Steve Smith with Cambridge Public Schools. This session will cover the basic requirements of the basic requirements of the major student privacy laws, FERPA, PPRA, COPPA, HIPAA, & CIPA. Attendees will come away with a basic understanding of the requirements of each of these laws in their school district. Emphasis will be place on operational impacts of each of these requirements on the day to day policies and procedures. Participants can expect to leave with a solid understanding of what may be required at the district level to meet ensure compliance with all student privacy regulations. This session will give a high-level overview of the various student data privacy laws, recommendations and policies that impact data stewards each day. This is a great introductory session for teachers, IT staff and administrators.

# STUDENT DATA PRIVACY CONSORTIUM (SDPC): THE MS ALLIANCE

Presented by Larry Fruth from Access 4 Learning (A4L – Student Privacy Alliance) and Steve Smith with Cambridge Public Schools. The Student Data Privacy Consortium (SDPC), which now has a Mississippi Alliance, is designed to address the day-to-day, real-world multi-faceted issues that schools, states, territories and vendors face when protecting learner information. This unique collaborative is addressing real-world, adaptable, and implementable solutions to growing data privacy concerns.
