#### OFFICE OF EDUCATOR LICENSURE

18. <u>Approval to Increase Praxis Tests Cut Scores</u>
(Has cleared the Administrative Procedures Act Process with public comment)

### **Background Information:**

The Commission on Teacher and Administrator Education, Certification and Licensure and Development convened a subcommittee, at the request of the State Superintendent, to review current passing scores on a selected group of Praxis tests. These tests were chosen because Mississippi scores are the lowest in the nation on these specific tests. The committee met with Educational Testing Service (ETS) and Mississippi Department of Education (MDE) officials to discuss and propose a recommendation to the Commission to increase the required passing scores for these tests. The information included in the back-up material shows the recommendations of the review committee.

The recommendation has been amended to increase the Mathematics (Test 0061) cut score to 128 to become effective September 1, 2012. Additionally, the cut score for the 0061 license will be increased to 130 effective September 1, 2014 and 132 effective September 1, 2016.

The Office of Educator Licensure will develop a Board policy to ensure that all Praxis scores will be reviewed every three (3) years.

Subject: Proposed Praxis II Test Cut Score Increase - Public Comment

Cindy – I am writing on behalf of the Barksdale Reading Institute in support of the proposed increase in the Praxis II test cut scores proposed by the State Board of Education at its May 18, 2012, meeting.

I chaired the education task force of Blueprint Mississippi in 2011, and increased Praxis II cut scores was a recommendation of that task force. We feel that this is essential to strengthening the teacher work force in the state which is, in turn, critical to the future strength of the schools. Consistent with this change in cut scores, the task force also has recommended strengthening the entry requirements for the state's schools of education (Praxis I). We hope to work with Dr. Bounds at IHL to accomplish that. As another component of our work, we also recommended a change in curricula at the schools of education to have more content-focused curricula. Finally, we have recommended a move toward merit-based compensation so that excellent teachers can be rewarded for their successes in the classroom; we have been keeping up with Daphne Buckley's work on that front.

Obviously, there are many other pieces to the very complex puzzle of education transformation. But the piece that dwarfs all others is having quality teachers in the classrooms. This board recommendation on cut scores is an important step in that direction.

Many thanks to the board, to Dr. Burnham, to you and to others who have gotten this moving.

Cindy,

First, I applaud our focus to raise the bar. I am sure you know that I support increasing our standards.

I have a couple of questions though.

- 1. We raised Special Education 354 to the second highest cut score in the nation. While I applaud raising the bar, we did not come closing to raising the bar in the other areas such as Social Studies and math.
- 2. Social Studies recommended score is 150 which will be the third lowest cut score in the nation. The average for this test is 154.
- 3. Math's recommendation is 128 which will be the 8th lowest in the nation. The average is 133.

I am glad we have decided to raise the bar, but if we are going to state we are going to align to the national average, then we need to get closer to that average.

Dear Sir/Mam,

I am writing to express my support for the increase in passing scores for the identified Praxis tests. I would like to recommend that the PLT test scores be included in the increase. The *Principles of Learning and Teaching* (PLT) test is valuable in assessing teacher candidates understanding of pedagogy and classroom management. Because these two are areas are most often associated with teacher effectiveness and student achievement, the low scores required now on the PLT should be reevaluated and increased. In addition, I strongly recommend that the PLT be added to the Praxis test requirements for alternative route teachers.

It would be my pleasure to present a full disclosure of the reasons to increase the required passing score on the PLT and to justify the inclusion for alternate route teachers.
