

West Bolivar School District:

Commence and begin at the northeast corner of Section 25, Township 21 North, Range 5 West, Bolivar County, Mississippi said corner lying on the east line of Bolivar County; thence run southerly on and along said county line and said east line of sections 25 and 36 to the southeast corner of said Section 36; thence continue on and along said county line westerly along the south line of said Township 21 North, Range 5 West to the northeast corner of Section 1, Township 20 North, Range 6 West; thence continue on and along said county line southerly along the east line of said Township 20 North, Range 6 West to the southeast corner of Section 36; thence continue on and along said county line along the south line of Township 20 North, Ranges 6 West, 7 West, 8 West, 9 West and 10 West to the Mississippi River and the southwest corner of Bolivar County; thence run more or less northerly on and along the meanderings of the Bolivar County line to its intersection with the northwest corner of Section 1, Township 25 North, Range 7 West; thence run easterly along the north line of said section 1 to the northwest corner of Section 6, Township 25 North, Range 6 West; thence run easterly on and along the north line of Sections 6, 5 and 4 to the northeast corner of said section 4, Township 25 North, Range 6 West; thence run southerly along the east line of sections 4, 9, 16, 21, 28 and 33 to the southeast corner of Section 33, Township 25 North, Range 6 West; thence run westerly along the south line of said section 33 to the southwest corner of said section 33, said corner also being the northeast corner of irregular section 5, Township 24 North, Range 6 West; thence run southerly along the east line of said section 5 to its southeast corner; thence run westerly along the south line of said section 5 and also the south line of section 6 to the northeast corner of section 12, Township 24 North, Range 7 West; thence run southerly on and along the east line of Township 24 North, Range 7 West and continuing along the east line of Township 23 North, Range 7 West to the northwest corner of Section 18, Township 23 North, Range 6 West; thence run along the north line of Sections 18 and 17 to the northeast corner of Section 17, Township 23 North, Range 6 West; thence run southerly along the east line of said section 17 to its southeast corner, said corner being common to sections 16, 22 and 21 of said Township; thence run easterly along the north line of said section 21 to its northeast corner; thence run southerly along the east line of said section 21 and continue thence along the east line of sections 28 and 33 to the northeast corner of Section 4, Township 22 North, Range 6 West; thence run southerly to the southeast corner of said section 4; thence run easterly on and along the north line of Section 10 of said Township to the northeast corner of the northwest quarter thereof; thence run southerly on and along the center of sections 10, 15 and 22 to the northwest corner of the northeast quarter of section 27; thence run easterly on and along the north line of Sections 27, 26 and 25 to the northeast corner of said Section 25; thence run southerly along the east line of sections 25 and 26, Township 22 North, Range 6 West and continue southerly on and along the east line of Sections 1, 12, 13 and 24 to the northwest corner of Section 30, Township 21 North, Range 5 West; thence run easterly along the north line of Sections 30, 29, 28, 27, 26 and 25 back to the northeast corner of said Section 25 and the point of beginning.
