02. <u>Approval of nonpublic school accreditation statuses for School Year 2015-2016</u> [Goals 1, 2, 3, 4, and 5 – MDE Strategic Plan]

Executive Summary

Annual accreditation statuses for nonpublic schools are assigned in December of each year and are determined by information verified during the previous school year (2014-2015). Accreditation statuses are based on compliance with the process standards as outlined in *Mississippi Nonpublic School Accountability Standards*, 2004.

Any nonpublic school may voluntarily request accreditation. Accreditation is determined by the extent to which the school complies with each of the nonpublic policies and standards. Initial accreditation requires any newly applying school to be fully operational and to substantiate compliance with all accreditation requirements. Each nonpublic school voluntarily seeking initial accreditation must have conducted a program of educational services for a period of at least one calendar year prior to date of proposed SBE accreditation. On-site accreditation audits of nonpublic schools are scheduled on a five-year cycle and conducted in the spring of each school year (approx. 12 per year). Each nonpublic school voluntarily seeking accreditation from the SBE is required to submit the Nonpublic School Accreditation Application annually in the fall of each school year.

Annual accreditation statuses are assigned in December of each school year and are determined by information verified during the previous school year. An assigned status remains in effect during that school year unless the correction of deficiencies upgrades a status.
