Minutes of Mississippi Board of Education Meeting

June 20, 2018

The members of the Mississippi Board of Education met in a Board work session at 2:06 p.m. on Wednesday, June 20, 2018, in the 4th Floor Boardroom at Central High School, 359 North West Street, Jackson, Mississippi. Board members present were: Ms. Rosemary G. Aultman, Mr. Buddy Bailey, Ms. Kami Bumgarner, Dr. Jason S. Dean, Dr. Karen J. Elam, Mr. Johnny Franklin, and Mr. Charles McClelland. Board members absent: Dr. John R. Kelly and Mr. Sean Suggs. Dr. Carey M. Wright was also present.

I. Ms. Rosemary G. Aultman, Chair, called the Board work session to order. Ms. Aultman noted that cellular telephones and pagers are not permitted during the meeting. Ms. Aultman stated the Board work session is being live streamed.

Dr. Gavin stated there are five major budget categories in the Department: General Education, Career and Technical Education, the Deaf and Blind Schools, Mississippi Adequate Education Program (MAEP), and Chickasaw. Dr. Gavin stated that the MAEP calculations will be brought to you in July. Dr. Gavin introduced Ms. Sharon Rosell, Director of Budget and Planning.
