07.A. Action: Award competitive grants for the Mississippi Community Oriented Policing Services in Schools Grant (MCOPS) FY22 (2021-2022) [Goal 2 – MBE Strategic Plan]

<u>Background and Purpose</u>: Mississippi Code Ann. § 37-3-82 established the Mississippi Community Oriented Policing Services in Schools (MCOPS) Grant program for the utilization of School Resource Officers (SRO) within the K-12 education system. The law allocates a minimum of \$10,000 per officer for Districts to pay for the salary and benefits of School Resource Officers. The funding must be matched from local funds on a 50/50 matching basis.

• Grant Period: July 15, 2021 - June 30, 2022

15, 2022)

Award Amount: \$ 1,600,000

Method of Award: Request for Proposals

Funding Source: State funds
