Minutes of Mississippi Board of Education Meeting

November 2, 2023

The members of the Mississippi Board of Education met in a Special-Called Board meeting at 9:00 a.m. on Thursday, November 2, 2023 for the purpose of reviewing candidate videos and resumes regarding the State Superintendent position. The location of the meeting was the Butler Snow Building – Ridgeland Room, Renaissance at Colony Park, 1020 Highland Colony Parkway #1400, Ridgeland, Mississippi 39157. Board members present were: Mr. Glen V. East, Dr. Wendi Barrett, Mr. Bill Jacobs, Dr. Ronnie L. McGehee, Mr. Matt Miller, Mr. Mike Pruitt, and Ms. Mary Werner.

- I. Mr. Glen V. East called the Special-Called Board meeting to order at 9:02 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Mr. East stated that this is a Special-Called meeting of the Board of Education being held today and the notice was posted in accordance with state law and included the date, time, place, and purpose of the meeting and identified the location of the meeting available to the public.
