## Minutes of Mississippi Board of Education Meeting

## December 12, 2023

The members of the Mississippi Board of Education met in a Special-Called Board meeting at 9:00 a.m. on Tuesday, December 12, 2023 for the purpose of conducting semi-finalist interviews for the State Superintendent position. The location of the meeting was the offices of Butler Snow at 1020 Highland Colony Parkway, Ridgeland, MS 39157. Board members present were: Mr. Glen V. - II.
