## Minutes of Mississippi Board of Education Meeting

## December 20, 2023

The members of the Mississippi Board of Education met in a Special-Called Board meeting at 2:00 p.m. on Wednesday, December 20, 2023 for the purpose of conducting finalist interviews for the State Superintendent position. The location of the meeting was the offices of Butler Snow at 1020 Highland Colony Parkway, Ridgeland, MS 39157. Board members present included: Mr. Glen V. East, Mr. Bill Jacobs, Dr. Ronnie L. McGehee, Mr. Matt Miller, Mr. Mike Pruitt, and Ms. Mary Werner. Board member absent: Dr. Wendi Barrett.

- I. Mr. Glen V. East called the Special-Called Board meeting to order at 2:00 p.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Mr. East stated that this is a Special-Called meeting of the Board of Education being held today pursuant to Miss. Code Ann. § 25-41-5. Mr. East stated that the notice was posted in accordance with state law and included the date, time, place, and purpose of the meeting and identified the location of the meeting available to the public. Mr. East stated that each Board member received a copy of the agenda. Mr. East stated that this is a Special-Called Board meeting and therefore the only business that can be transacted is that which has been specified in the call of this meeting.
- III. On a motion by Dr. Ronnie L. McGehee, seconded by Ms. Mary Werner, the Board unanimously approved the agenda as presented.
