Background Information: State Board Policy Chapter 28, Rule 28.1 – Curriculum Guides is being in accordance with Miss. Code Ann. § 25-43-3.114 which requires an agency to review all of its rules at least every five years to determine whether any rule should be repealed, amended, or a new rule adopted.

State Board Policy Rule 28.1 is being revised to eliminate outdated information and ensure that the MDE can maintain an up-to-date copy of each framework.

The public comment period was open from October 19, 2023, through 5:00 p.m. November 13, 2023. The MDE received no public comments.
