Minutes of Mississippi Board of Education Meeting

March 9, 2023

The members of the Mississippi Board of Education met at 10:00 a.m. on Thursday, March 9, 2023, pursuant to Miss. Code Ann. § 25-41-5 for the purpose of conducting a regularly scheduled Board meeting.

The public accessed this meeting via livestream or in-person at the Madison County School District Boardroom, Ridgeland, Mississippi. Board members physically present included: Ms. Rosemary G. Aultman, Dr. Wendi Barrett, Mr. Glen V. East, Dr. Ronnie L. McGehee, Mr. Matt Miller, and Ms. Mary Werner. Board member participating virtually: Mr. Bill Jacobs (Phoenix, Arizona). Student Representatives present: Ms. Micah Hill and Mr. Charlie Frugé. Dr. Robert P. Taylor, State Superintendent, was also present.

- I. Ms. Rosemary G. Aultman called the Board meeting to order at 10:00 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Ms. Micah Hill led the Pledge of Allegiance and Dr. Wendi Barrett gave the Invocation.
- III. On a motion by Ms. Mary Werner, seconded by Dr. Wendi Barrett, the Board unanimously approved the minutes of the February 16, 2023, Board meeting.
- IV. On a motion by Dr. Ronnie L. McGehee, seconded by Mr. Matt Miller, the Board unanimously adopted the agenda as presented.
- V. No Recognition Ceremony.
- VI. Dr. Robert P. Taylor gave the following report as the State Superintendent of Education:
 - Dr. Taylor stated he is continuing to meet with legislators to share his priorities and understand what is important to them.
 - Dr. Taylor stated the Accountability Taskforce met yesterday to discuss topics including growth, attendance, and potential indicators of school quality and student success. Dr. Taylor stated that Ms. Aultman and Mr. East attended the meeting as State Board representatives.
 - Dr. Taylor stated that he has visited all but one of the lowest performing school districts and will visit the remaining district soon. Dr. Taylor stated the visits have helped him to understand the challenges the districts face and ensure MDE is providing every possible means of support.
 - Dr. Taylor stated he met with the Principal Advisory Council and the Teacher Advisory Council. Dr. Taylor stated that the principals provided input about improving the orientation program for new school leaders and increasing student access to advanced coursework. Dr. Taylor stated the

teachers gave feedback about the new Mississippi Educator Career Continuum Archive (MECCA) licensure system. Dr. Taylor thanked Dr. Cory Murphy for his hard work.

- Dr. Taylor stated he delivered remarks at the Mississippi School Boards
 Association Annual Conference and spoke at the East Mississippi Center for
 Educational Development (EMCED) Special Education Conference. Dr.
 Taylor stated this gave him the opportunity to meet with district leaders from
 throughout the state.
- Dr. Taylor talked about his five priorities: Literacy and Mathematics, Low Performing Schools, Teacher Shortage, Career and Technical Education Certifications, and Early Childhood Education.

VII. Ms. Rosemary G. Aultman, Chair of the State Board, gave the following report:

- Ms. Aultman stated she brought greetings and a welcome from the Board to the Mississippi School Boards Association.
- Ms. Aultman welcomed Ms. Jennifer Nichols as the Attorney for the Board.
- Ms. Aultman stated she has been working to prepare the Board Retreat with McPherson & Jacobson for April 19, 2023.
- Ms. Aultman thanked Dr. Cory Murphy for his hard work on the new licensure system.
- Ms. Aultman stated that she and Mr. East attended the Accountability Taskforce meeting to look at the accountability system.
- Ms. Aultman stated that she has monitored the legislation while the session is going on and thanked Ms. Holly Spivey for all the work she has done.

Mr. Charlie Frugé and Ms. Micah Hill gave a joint report on the Student Advisory Council (SAC) meeting that was held on February 10, 2023, at the State Capitol. Ms. Hill stated that this meeting gave she and Mr. Frugé an opportunity to hear different perspectives and solutions on issues affecting our students.
