Minutes of Mississippi Board of Education Meeting

June 15, 2023

The members of the Mississippi Board of Education met at 10:00 a.m. on Thursday, June 15, 2023, pursuant to Miss. Code Ann. § 25-41-5 for the purpose of conducting a regularly scheduled Board meeting.

The public accessed this meeting via livestream or in-person at the Central High School Building, 4th Floor Boardroom, 359 North West Street, Jackson, Mississippi. Board members physically present included: Dr. Wendi Barrett, Mr. Glen V. East, Mr. Bill Jacobs, Mr. Matt Miller, and Mr. Mike Pruitt. Board members participating virtually: Dr. Ronnie L. McGehee (Biloxi, Mississippi) and Ms. Mary Werner (Saltillo, Mississippi – joined at 10:04 a.m.). Student Representative absent: Mr. Charlie Frugé. Mr. Michael D. Kent, Interim State Superintendent, was also present.

- I. Mr. Glen V. East called the Board meeting to order at 10:00 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Mr. Matt Miller led the Pledge of Allegiance and Dr. Wendi Barrett gave the Invocation.
- III. On a motion by Mr. Bill Jacobs, seconded by Dr. Wendi Barrett, the Board voted 5 to 0 to approve the minutes of May 18, 2023.

V. Recognition Ceremony

- VI. Mr. Michael D. Kent gave the following report as the Interim State Superintendent of Education:
 - Mr. Kent stated that MDE staff have been busy this month closing out the 2022-23 school year and preparing for the new school year. Mr. Kent stated that MDE had the pleasure of meeting with our newest Board member, Mr. Mike Pruitt, and providing him with an initial orientation.
 - Mr. Kent stated that districts are expected to receive their statewide assessment results for grades 3-8 for review tomorrow. Mr. Kent stated this is one of the first steps in the accountability process that determines school and district grades for the 2022-23 school year.
 - Mr. Kent stated that as he mentioned previously, Dr. Paula Vanderford will be reaching out to the directors of each of the six Regional Education Service Agencies (RESAs) about conducting very focused discussions with superintendents during their meetings concerning specific areas where the Statewide Accountability System can be improved or strengthened. Mr. Kent stated that the Accountability System remains a constant area of interest to superintendents, so we want to continue to engage in discussions with them about what degree of change, if any, is needed to the system.
 - Mr. Kent stated that regarding the \$100 million funding allocation to districts, MDE has done all that we can do to help districts complete their budgeting process. Mr. Kent stated that MDE still does not have confirmation from the Legislature about how to calculate the disbursement of the \$100 million appropriation to districts based on average daily enrollment. Mr. Kent stated that MDE provided the districts with guidance about estimating their allocation based on an approximate per-pupil allocation of \$236 and we hope this information will help districts get further along in their budget process. Mr. Kent stated that once MDE receives approval of the calculation from the Legislative Budget Office, MDE will immediately send the final allocations to districts.
 - Mr. Kent stated that himself, Dr. Donna H. Boone, and Ms. Holly Spivey met with Mississippi Department of Human Services (MDHS) Executive Director, Mr. Bob Anderson, to discuss the implementation of Mississippi's federal Preschool Development Grant. Mr. Kent stated this \$30 million grant will be dispersed over the next three years to improve access to high-quality early childcare and education programs. Mr. Kent stated along with MDHS and MDE, grant partners include the Mississippi Early Childhood Inclusion

- Center, the Children's Foundation of Mississippi, and the Mississippi State University Social Science Research Center.
- Mr. Kent stated that himself. Dr. Boone, and Ms. Spivey met with State Workforce Development Board Chairman, Mr. Patrick Sullivan, to clarify an issue regarding industry certifications. Mr. Kent stated the State Workforce Development Board known as SWIB is responsible for approving industry certifications for program offerings, accountability, and reimbursement to districts. Mr. Kent stated that on June 20, 2023, MDE will go back to determine the final list of industry certifications to bring to the Board in July.
- Mr. Kent stated that he wanted to highlight how much national and international coverage Mississippi has been getting lately for our successful work in the areas of student achievement and teacher preparation. Mr. Kent stated at your table you have two examples: the first is a May 31st article by the two-time Pulitzer Prize winning New York Times columnist, Mr. Nicholas Kristof. Mr. Kristof traveled to Jackson and the Mississippi Delta in April because he was skeptical about the progress Mississippi had made in education. Mr. Kent stated that you can see in his article that he is no longer skeptical. Mr. Kent stated this past month MDE hosted a documentary film crew from South Korea's public educational broadcasting company, which is featuring Mississippi in a 10-part documentary about reading and literacy.
- Mr. Kent stated MDE received positive media coverage this month for our literacy work from national news outlets including Fox News, PBS, and Education Week, and local news outlets including Mississippi Today, WLBT, and WJTV.
- Mr. Kent stated that the second example at your table is the executive summary and our news release about a report from the National Council on Teacher Quality (NCTQ) that recognizes Mississippi as one of the top two states for ensuring scientifically based reading instruction in their teacher preparation programs. Mr. Kent stated the report provides the most up-todate information available on how teacher preparation programs prepare aspiring teachers to teach children to read.
- Mr. Kent stated he wanted to commend the entire MDE staff and all the teachers and administrators in the field who raised standards for what students can accomplish and equipped themselves to help students reach those higher academic standards. The world is taking notice.
- VII. Mr. Glen V. East, Acting Chair of the State Board, gave the following report:
 - Mr. East welcomed the new Board member, Mr. Mike Pruitt, who was appointed by Speaker Gunn on May 16, 2023.
 - Mr. East stated that Mr. Pruitt attended a new Board member orientation session with MDE leadership on June 8, 2023.
 - Mr. East stated that 28 applications were received from across the state for the Junior Student Representative position, the State Board conducted interviews with the top four finalists yesterday. Mr. East stated that all of the

candidates were exceptional students and the Board enjoyed getting to know each of them through the process. Mr. East stated the following Junior Student Representative appointments were made: Ms. Kate Riddle from Lafayette County School District was selected as the Junior Student Representative and Ms. Yaerim Choi from Mississippi School for Mathematics and Science was selected the Junior Student Representative alternate. Mr. East stated that the Junior Student Representative will serve a two-year term on the State Board starting July 1, 2023, to June 30, 2025.

XI. Consideration of Executive Session
