Minutes of Mississippi Board of Education Meeting

September 28, 2023

The members of the Mississippi Board of Education met at 10:00 a.m. on Thursday, September 28, 2023, pursuant to Miss. Code Ann. § 25-41-5 for the purpose of conducting a regularly scheduled Board meeting.

The public accessed this meeting via livestream or in-person at the Central High School Building, 4th Floor Boardroom, 359 North West Street, Jackson, Mississippi. Board members physically present included: Mr. Glen V. East, Dr. Wendi Barrett, Mr. Bill Jacobs, Dr. Ronnie L. McGehee, and Ms. Mary Werner. Board members participating virtually: Mr. Matt Miller (Hattiesburg, Mississippi) and Mr. Mike Pruitt (Hattiesburg, Mississippi). Student Representatives present: Ms. Kate Riddle and Mr. Charlie Frugé. Dr. Raymond C. Morgigno, Interim State Superintendent, was also present.

- I. Mr. Glen V. East called the Board meeting to order at 10:00 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Dr. Wendi Barrett led the Pledge of Allegiance and Ms. Mary Werner gave the Invocation.
- III. On a motion by Ms. Mary Werner, seconded by Dr. Ronnie L. McGehee, the Board unanimously approved the minutes of August 17, 2023, Board meeting.

- VI. Dr. Raymond C. Morgigno gave the following report as the Interim State Superintendent of Education:
 - Dr. Morgigno stated the Regional Superintendents meetings were held at all six of the RESAs. Dr. Morgigno stated that Dr. Ronnie L. McGehee joined in Meridian and Dr. Wendi Barrett joined on the Coast for dinner.
 - Dr. Morgigno stated the Teacher Advisory Council meetings were held in three locations across the state.

- Dr. Morgigno stated that Mississippi's trophy for the 2023 Frank Newman Award for State Innovation arrived from the Education Commission of the States.
- Dr. Morgigno stated the U.S. Department of Education recognized the MDE Special Education Team for its June 2023 conference that impacted over 600 educators across the state.
- Dr. Morgigno recognized the MDE Communication Team who won two awards from the Southern Public Relations Federation for the 2022 Accountability Communication Toolkit and the 2021-2022 Superintendent's Annual Report. Dr. Morgigno stated the awards recognize top work produced by communication professionals in Alabama, Florida, Louisiana, and Mississippi.
- VII. Mr. Glen V. East, Chair of the State Board, gave the following report:
 - Mr. East stated that the Mississippi Grade Level Campaign is a great thing in Literacy across the state.
- VIII. Reports from Student Representatives

Ms. Kate Riddle reported on the effects a school counselor has on the lives of their students.

Mr. Charlie Frugé reported on the importance of Early Childhood Literacy.

IX. Reports on State Board of Education Subcommittee meetings

Dr. Wendi Barrett, Chair of the Academic Achievement PreK-12/Early Childhood Subcommittee, stated Dr. Jill Dent gave an update on the State Invested Pre-Kindergarten Program grants that will be presented to the Board today. Dr. Barrett stated the grants are for \$6.7 million for nine (9) districts and three (3) of the districts will be working with Head Start. Dr. Barrett stated the remaining \$7 million will be used to expand the existing programs for the districts that are currently in the cohort. Dr. Barrett stated a new RFA will be released soon for the Early Learning Collaborative Act for districts to apply for \$2.5 million. Dr. Barrett stated Dr. Sonja Robertson stated there were 22 comments received and only three were related to the exit criteria for ATSI and CSI that will be presented to the Board today. Dr. Barrett stated the identification for school improvement schools is tentatively set for October 9, 2023. Dr. Barrett stated the cycle for identification of schools in school improvement will begin this year as an every three year cycle and they are continuing to work toward setting a cut score for ATSI schools so it will stay the same as when they entered. Dr. Barrett stated that Dr. Donna H. Boone stated there is a deficit in the middle school in grades 5-8 in literacy and after looking at the data MDE is working on a pilot with Title II funds to help teachers with this issue. Dr. Barrett stated they will also look at math in grades 5-8.

Mr. Bill Jacobs, Chair of the Internal Accountability Subcommittee, stated their last meeting was Monday afternoon and they had a discussion about the LITE report and the Paper on Demand Tutoring Program. Mr. Jacobs stated the biggest thing was the discussion about the compliance office and duplication of internal audits. Mr. Jacobs stated that Dr. Morgigno made some excellent suggestions that they must define the duties of the compliance office and of internal audit. Mr. Jacobs stated they have to clarify what each one's supposed to do but more importantly we have moved the fraud, waste and abuse hotline from the compliance office to the internal audit office. Personnel matters and complaints will be handled by HR.

Ms. Mary Werner, Chair of the Workforce/Career and Technical Education Subcommittee stated she wanted to let everyone know the good work being done in CTE and she showed a copy of the *Connections* magazine. Ms. Werner gave the Board the web site they could go online and look at the current and previous editions.

On a motion by Mr. Matt Miller, seconded by Ms. Mary Werner, the Board voted 5 to 0 to come out of Executive Session.

The public came back into the Board meeting and Mr. East stated the Board discussed the State Superintendent search process.

Mr. East stated the recruitment period for the State Superintendent of Education began on August 14, 2023, and will close on October 19, 2023. The position announcement is posted on the MDE website, the McPherson & Jacobson website, and it has been shared nationally by the search firm.

On September 5, 2023, the Communications Office released a Stakeholder Survey for public comments which closed on September 19, 2023.

On November 2, 2023, the State Board will meet with McPherson & Jacobson consultants to discuss the candidates who applied for the position, view applicant videos, and select the semi-finalists for interviews on December 11 and 12, 2023. Following the semi-finalist interviews, finalist(s) will be selected for interview on December 20, 2023. The State Superintendent will be appointed by the State Board on December 20, 2023, with a hire date of July 1, 2024, upon Senate confirmation.
