06. <u>Action: Approval of 2017-2018 accountability results for Corinth School District,</u> <u>Harrison County Child Development Center, Pascagoula Gautier Exceptional</u> <u>School, Mississippi School for the Blind, and Mississippi School for the Deaf</u> [Goals 1, 2, and 6 – MBE Strategic Plan]

<u>Background Information</u>: On September 18, 2018 the Commission on School Accreditation (CSA) met in a regularly scheduled meeting and approved the 2017-2018 Mississippi Statewide Accountability Results. On September 20, 2018, the State Board of Education (SBE) delayed the release of the 2017-2018 Mississippi Statewide Accountability results to allow the Board members additional time to review the results. On October 11, 2018 the SBE approved the 2017-2018 Mississippi Statewide Accountability results, with the exception of four (4) schools with special populations, three (3) schools within the Corinth School District and the Corinth School District.
