WHEREAS, Licensor is the sole source provider of the Classroom Assessment Scoring System (CLASS®) and is amenable to providing to MDE pursuant to the terms and conditions of this Agreement; and

WHEREAS, ITS issued a Notice of Intent to Certify Sole Source No. 4314 in an attempt to certify the sole source status of this procurement; and

WHEREAS, there being no objections to the sole source status being filed by any person or entity and the parties thereby determining this is indeed a sole source project;

NOW THEREFORE, ITS, MDE, and Licensor, by entering into this Amendment Number 1, mutually agree that the following provisions shall modify the aforementioned Agreement:

- 1) Article 2.1 under "Period of Performance" is amended so as to extend the Agreement until the close of business on August 31, 2020.
- 2) The third and fourth sentences of Article 23 "Notice" are revised to read: "Licensee's address for notice is: Mr. John Kraman, Chief Information Officer, Mississippi Department of Education, 359 North West Street, Jackson, Mississippi 39201. Licensor's address for notice is: Ms. Amy Marciniak, Client Success Manager, Teachstone, Inc., 675 Peter Jefferson Parkway, Suite 400, Charlottesville, Virginia 22911."

All other terms and conditions of the Agreement executed on July 12, 2017, shall remain unchanged and in full force and effect.
