

## Minutes of Mississippi Board of Education Meeting

November 2, 2023

The members of the Mississippi Board of Education met in a Special-Called Board meeting at 9:00 a.m. on Thursday, November 2, 2023 for the purpose of reviewing candidate videos and resumes regarding the State Superintendent position. The location of the meeting was the Butler Snow Building – Ridgeland Room, Renaissance at Colony Park, 1020 Highland Colony Parkway #1400, Ridgeland, Mississippi 39157. Board members present were: Mr. Glen V. East, Dr. Wendi Barrett, Mr. Bill Jacobs, Dr. Ronnie L. McGehee, Mr. Matt Miller, Mr. Mike Pruitt, and Ms. Mary Werner.

- I. Mr. Glen V. East called the Special-Called Board meeting to order at 9:02 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Mr. East stated that this is a Special-Called meeting of the Board of Education being held today and the notice was posted in accordance with state law and included the date, time, place, and purpose of the meeting and identified the location of the meeting available to the public. Mr. East stated that each Board member received a copy of the agenda. Mr. East stated that this is a Special-Called Board meeting and therefore the only business that can be transacted is that which has been specified in the call of this meeting.
- III. On a motion by Ms. Mary Werner, seconded by Mr. Mike Pruitt, the Board unanimously approved the agenda as presented.
- IV. Consideration of Executive Session

Mr. Matt Miller moved that the Board consider making a closed determination of the need to go into Executive Session. Dr. Ronnie L. McGehee seconded the motion, and the motion passed unanimously. Mr. Glen V. East asked for the room to be cleared.

Mr. Matt Miller then moved that the Board go into Executive Session in accordance with Miss. Code Ann. § 25-41-7(4)(a) and (k) to discuss discrete personnel matters related to the State Superintendent search process for the Department of Education. Dr. Ronnie L. McGehee seconded the motion, which passed unanimously. Ms. Jennifer Nichols informed the public of the Board's vote to go into Executive Session for the above stated reason.

During the Executive Session, the Board reviewed candidate videos and resumes regarding the State Superintendent search and had discussions related to this process.


On a motion by Mr. Matt Miller, seconded by Dr. Ronnie L. McGehee, the Board unanimously voted to come out of Executive Session.
