

Minutes of Mississippi Board of Education Meeting

March 27, 2023

The members of the Mississippi Board of Education met in a Special-Called Teleconference Board meeting at 4:30 p.m. on Monday, March 27, 2023, for the purpose of discussing personnel matters related to appointments within the MDE. The meeting's public location was in the Conference Room at the LifeShare House on the campus of the Mississippi Schools for the Deaf and the Blind, 1252 Eastover Drive, Jackson Mississippi. Board members present via Zoom were: Ms. Rosemary G. Aultman (Clinton, Mississippi), Dr. Wendi Barrett (Ocean Springs, Mississippi), Mr. Glen V. East (Gulfport, Mississippi), Mr. Bill Jacobs (Brookhaven, Mississippi), Dr. Ronnie L. McGehee (Tupelo, Mississippi), Mr. Matt Miller (Hattiesburg, Mississippi), and Ms. Mary Werner (Salttilo, Mississippi).

- I. Ms. Rosemary G. Aultman called the Special-Called Board meeting to order at 4:34 p.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting through teleconference and video means in accordance with Miss. Code Ann. § 25-41-5.

Ms. Aultman stated that this is a Special-Called meeting of the Board of Education and the notice was posted in accordance with state law and included the date, time, place, and purpose of the meeting and identified the location of the meeting available to the public. Ms. Aultman stated that each Board member received a copy of the agenda. Ms. Aultman stated that this is a Special-Called Board meeting and therefore the only business that can be transacted is that which has been specified in the call of this meeting.

- II. On a motion by Ms. Mary Werner, seconded by Mr. Bill Jacobs, the Board unanimously approved the agenda as presented.
- III. Consideration of Executive Session

Mr. Glen V. East moved that the Board consider making a closed determination of the need to go into Executive Session. Mr. Matt Miller seconded the motion, and the motion passed on a vote of 6 to 0. Ms. Rosemary G. Aultman asked for the room to be cleared.

Code Ann. § 25-41-7(4)(a) and (k) to discuss discrete personnel matters related to appointments within the MDE. Ms. Mary Werner seconded the motion, which passed on a vote of 6 to 0. Ms. Jennifer Nichols informed the public of the Board's vote to go into Executive Session for the above stated reason.

Minutes of the Executive Session


During the Executive Session, the Board discussed discrete personnel matters related to appointments within the MDE.
