## I. Announcement of Quorum and Call to Order

Heather Westerfield, Chair of the CSA, opened the Commission meeting and conducted a roll-call of the Commission members.

Ms. Westerfield announced that a quorum of the Commission existed.

Ms. Westerfield called the meeting to order at 2:03 p.m.

## II. Adoption of Agenda

Ms. Westerfield asked the Commission members to review the agenda they received previously. On a motion by Sean Brewer seconded by Sarah Foster, the Commission unanimously approved the agenda.

III. Discussion and consideration of proposed changes to the business rules of the Mississippi Statewide Accountability System to reset the baseline scores in accordance with current State Board of Education policy for schools with Grade 12 effective school year 2017-2018 as recommended by the Mississippi Technical Advisory Committee (TAC).

Dr. Vanderford explained that the State Board of Education, on August 16, 2018 remanded the Commission 's August 14<sup>th</sup> decision back to the Commission for further consideration because of concerns expressed by Commission members of not having adequate time to review information before needing to make a decision. Alan Burrow made a presentation to the Commission which explained how the issues of multiple assessments over multiple years has impacted the growth measurement and predicted results of the Mississippi Statewide Accountability System

Ann Jones and Eddie Prather asked for clarity on the history of the PARCC assessments and their impact on accountability calculations.

Sean Brewer stated that he would like to see the use of the cut stores from 2015-2016 but Dr. Vanderford explained that doing so would not be using a baseline of MAAP to MAAP comparison.

Brian Harvey asked about the impact of the EL component for next year's accountability and whether the possibility exists in having to reset the baseline next year. Dr. Vanderford responded indicating there is a possibility of having to reset the baseline again next year due to any unforeseeable impact, such as the new EL component as well as any another unforeseen changes in statute.

Alan Burrow reminded the Commission that the cut-scores being presented could change after the final data is run and that the Commission would be voting on percentiles not specific cut scores.

IV. Approval to submit request to the State Board of Education to begin the Administrative Procedures Act (APA) process to revise the business rules of the Mississippi Statewide Accountability System to reset the baseline scores in accordance with current State Board of Education policy for schools with Grade 12 effective school year 2017-2018 as recommended by the Mississippi Technical Advisory Committee (TAC).

On a motion by Michael Lindsey, seconded by Roy Gill, the Commission voted unanimously to submit a request to the State Board of Education to begin the Administrative Procedures Process Act process to revise the business rules of the Mississippi Statewide Accountability system to reset the baseline scores in accordance with current State Board of Education policy for schools with Grade 12 effective school year 2017-2018 as recommended by the Mississippi Technical Advisory Committee (TAC).

## V. Adjournment

On a motion by Sarah Foster, seconded by Eddie Prather, the Commission unanimously voted to adjourn the meeting at 2:50 p.m.
