## VII. Action: Approval to Upgrade the Accreditation Status of the Philadelphia School District from PROBATION to ACCREDITED

On a motion by Michael Lindsey seconded by Eddie Prather, the Commission unanimously voted to upgrade the Accreditation Status of the Philadelphia School District from PROBATION to ACCREDITED.

## VIII. Action: Approval to Downgrade the Accreditation Status of the Pearl River County School District from ACCREDITED to PROBATION

Dr. Vanderford explained that the MDE notified the district in July of their recommended accreditation status of PROBATION but was erroneously placed on the list for ACCREDITED during the September 18, 2018 Commission meeting.

On a motion by Ann Jones seconded by Dr. Valencia Martin, the Commission unanimously voted to downgrade the accreditation status of the Pearl River County School District from ACCREDITED to PROBATION

#### IX. Other business

Dr. Vanderford announced that Michael Lindsey will be representing the Commission on the Accountability Task Force for the upcoming year.

Dr. Vanderford thanked Leah Kathryn Anzenberger for sitting in for Erin Meyer as legal counsel for today's meeting.

#### Commission on School Accreditation-MINUTES October 4, 2018

Dr. Vanderford announced that she would no longer be serving as the Executive Secretary for the Commission. Dr. Wright has appointed Dr. Jo Ann Malone, Executive Director of the Office of Accreditation, as the Executive Secretary for the Commission.

Dr. Vanderford announced that Rob Tyner has resigned from his seat on the Commission. As Mr. Tyner has resigned from his seat as a member of the Clarksdale Municipal School Board, he is no longer eligible to serve on the Commission as a local school board member representative. Dr. Vanderford asked the Commission to consider potential candidates to serve as his replacement and stated that the member will be required to live in Congressional District 2 (2002 map). Recommendations will be presented to Dr. Wright and the State Board of Education for final approval.

The next regularly scheduled Commission meeting is scheduled for Thursday, December 6, 2018.

Kelle Barfield asked if the K-12 Attendance Center Task Force would be meeting before the Commission meets on December 6<sup>th</sup>. Dr. Malone explained they plan to set a date for the next K-12 Attendance Center Task Force meeting as soon as the State Board approves the final accountability ratings; however, they plan to meet before December 6<sup>th</sup>.

Heather Westerfield thanked Dr. Vanderford for her service to the Commission.

Dr. Vanderford informed the Commission that Dr. Wright has appointed Dr. Cory Murphy as the new Executive Secretary of the Commission on Teacher and Administrator Education, Certification and Licensure and Development.

On a motion by Michael Miller, seconded by Dr. Valencia Martin, the Commission unanimously voted to adjourn the meeting at 10:24 a.m.
