I. In the Matter of Mississippi Educator License No. 296812, Nicole Moreno Collums, Application for Reinstatement

Kim Turner, legal advisor to the Subcommittee, called the hearing to order at 12:56 p.m. After all exhibits were received into evidence and testimony heard, Kim Hubbard moved to close the session to determine whether the Subcommittee should enter into an Executive Session. Upon a second to the motion by Dr. Shelly Simmons, the Subcommittee voted unanimously to close the session.

Kim Hubbard made a motion for the Subcommittee to enter into an Executive Session to deliberate and consider the evidence presented with regard to the present case pursuant to Miss.
