I. Educator License No. 202487, Leonardo Thompson.

Dr. Debra Mays Jackson, serving as presiding officer for the Commission Hearing Subcommittee, called the hearing to order at 11.34 a.m.

After all exhibits were received into evidence and testimony heard, Jamie Creel moved that the subcommittee go into closed session to determine the necessity to go into executive session. Kim Hubbard seconded the motion and the Commission Hearing Subcommittee unanimously voted to go into closed session.

Kim Hubbard moved that the Commission Hearing Subcommittee go into executive session for deliberation and findings concerning the license of the above identified Educator. Jamie Creel seconded the motion, and the Commission Hearing Subcommittee unanimously approved the processing of Educator License No. 202487, placing the educator immediately on probation with conditions.
