– Federal Reporting Requirements

- District Summary Reporting
 - Student Performance instead of Program Performance
 - Disaggregation of Student Data
- District Summary Improvement Plans
 - Identify Subpopulations of Students for Improvement
 - Subpopulations are Gender, Race, and Special Populations
- Local Plan Updates (LPU) - Federal Grant Management
 - Revised Local Plan Application
 - District DUNS Numbers on Budget Requests
 - Local Plan Use of Funds - Student Organization Travel (National Competition for 1st place State Winners)

– CTE Special Populations Indicators

- Identify special populations status of CTE students
- Indicators include Single parent, homeless, ELL, etc.

– Non-Traditional Student Indicators

- Non-Traditional Programs were revised and updated nationally
- Changes affected State Non-Traditional Indicators on District Summary Report

– CTE Teacher Budget

- Teacher Budget data must be entered in July 2017 after MSIS opens in order for districts to receive August 2017 Salary Reimbursement
- All CTE Directors or Contact Persons must have access to the CTE Teacher Budget.
- To ensure districts receive all final funds for the year, the June CTE reimbursement is issued in July to allow CTE Directors to make any final adjustments to the teacher budget by June 30th.

SY18 CTE Reporting in MSIS Personnel/MAEP Teacher Unit (TU) Edit Report

- MAEP TU Edit checks and resolutions **MUST begin** in Month 01 – October of each year to ensure problems are resolved before the district loses access to MSIS after December 10th.
- A districts failure to resolve TU Edit issues by December 10th **will result** in a loss of CTE MAEP funds.
- CTE Directors should have access to the MAEP TU Edit Report for CTE teachers. If they do not, the MSIS Coordinator **must** make sure the CTE Director or Contact Person receives a TU Edit Report for each CTE Teacher.

COMMON ERRORS

- Missing TU Edit Reports for CTE Teachers means there is an error preventing the teacher's page from printing. **(The district will lose CTE MAEP funding if problem is not resolved.)**
- The CTE teacher's general schedule does not have the special program code "2" for CTE entered in MSIS. **(The district will lose CTE MAEP funding if problem is not resolved.)**

SY2018 CTE Reporting in MSIS

District Summary Reporting

- Federal guidelines require state and local districts to report disaggregated data on the performance of students in subpopulations: special populations, gender, race, and ethnicity.
- Special populations indicators include economically disadvantaged, homeless, limited English proficiency, migrant, non-traditional, single parent, and disability.

SY2018 CTE Reporting in MSIS

District Summary Reporting

- Districts must select special populations indicators for CTE students, as deemed necessary. Failure to do so will effect on end of year federal reporting.
- If districts have to submit an improvement plan for programs that failed to meet performance measures, the district must use the disaggregated data to:
 - Identify disparities or gaps in performance in subpopulations and
 - Describe measures that will be taken during the next school year to address those disparities and improve performance.
