IV. Adjournment

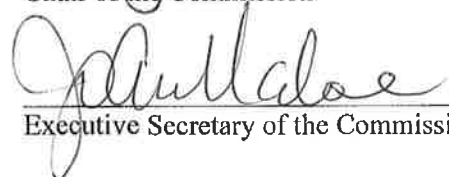
On a motion by Brad Stevens, seconded by Brian Harvey, the Commission unanimously voted to adjourn the meeting at 10:13 a.m.
