Re: Agricultural High Schools

Please find attached a comparison of the academic performance of the agricultural high schools and the districts surrounding each of them. As you can see both Hinds AHS and Coahoma AHS are "F's" and neither met growth. Forrest AHS, on the other hand, was the second highest performer in Forrest County.

In terms of enrollment both Hinds AHS and Coahoma AHS are quite small and are experiencing serious declines in enrollment. Forrest AHS has 615 students and has grown by 12% in the past 5 years.

Also, as we discussed, the Forrest County Board of Supervisors levies 3.16 mils on all the citizens of Forrest County including those in the Hattiesburg and Petal school districts in order to fund the \$1.3 million annual operating budget of Forrest AHS. If the Forrest AHS board (and their taxing authority) were abolished there would be a statutory challenge to transferring that 3.16 mil levy to the Forrest County School District because they are already at the 55 mil cap.

In addition to that challenge, the Forrest County Board of Supervisors has recently approved a \$4 million bond issue to fund new construction (additional classrooms and auditorium) on the Forrest AHS site.
