OFFICE OF ACCREDITATION

21. <u>Discussion of days missed by school districts as a result of Hurricane</u> Isaac

Pursuant to MS Code 37-13-63, the State Board of Education is authorized to allow a school district to alter its calendar on a case-by-case basis in the event of a natural disaster or extreme weather emergency in which the Governor has declared a state of emergency. If a school board of any school district shall determine that it is not economically feasible or practicable to operate any school within the district for the full one hundred eighty (180) days required for a full school term as required in Section 37-13-63 of the *Mississippi Code* and Standard 19 as published in the *Mississippi Public School Accountability Standards*, said school board may notify the State Department of Education of such disaster or weather emergency and submit a request to alter the school term.

Emergency weather conditions resulting from intense flooding and tornadic activity associated with Hurricane Isaac have caused many school districts in our state to miss days during the fall of 2012.

In accordance with Section 37-13-63, the State Board of Education may permit the school board to operate in its district for less than 180 days.

Subject: Hurricane Isaac Data Collection

Many school districts in our state experienced unexpected closings due to inclement weather associated with Hurricane Isaac. As a result of these closings, the current calendar for some districts will not reflect the minimum instructional time per day and 180 teaching days as required by state statute, State Board Policy, and Accreditation Standards. Accreditation Standard 19, as approved by the State Board of Education and published in *Mississippi Public School Accountability Standards*, 2012, requires each school district to provide a minimum of 180 teaching days in which both teachers and pupils are in regular attendance for scheduled classroom instruction for not less than sixty percent (60%) of the normal school day. Standard 19 also requires 330 minutes of instructional time per day or 27.5 hours of instructional time per week.

Current legislation gives the State Board of Education (SBE) the authority to grant exceptions when **catastrophic conditions** exist, the Governor or President has declared a disaster emergency, and it would not be **economically feasible or practical** for the district to make up the days missed prior to the end of the school year. Since a state of emergency was declared as a result of Hurricane Isaac, the Office of Accreditation is collecting data for consideration by the SBE when making its decision.

Please complete the attached *Hurricane Isaac Data Collection Form* and return to the Office of Accreditation no later than 12:00 p.m., Wednesday, September 12, 2012. We apologize for the quick turn around, but we would like to present this information to the SBE at its September meeting. You may submit your information by emailing <u>pvanderford@mde.k12.ms.us</u> or faxing it to 601.359.1979. <u>All</u> districts must submit a response to the Office of Accreditation even if no days were missed. The collection of this data does not suggest that the SBE will be granting waivers for making up all days missed.
