12. <u>Approval of Proposal from William Carey University to Modify its Masters of Arts</u> in Teaching Program to Include a Special Education Track as Recommended by the Commission on Teacher and Administrator Education, Certification and Licensure and Development

Background Information:

The School of Education at William Carey University currently offers two tracks in the Masters of Arts in Teaching program (MAT): Elementary Education (4-6) and Secondary Education (7-12). With the State Board of Education's approval to offer Special Education within all approved alternate route programs, William Carey proposes to add the third track that allows a special education teacher candidate to earn 21 hours in Mild and Moderate Disabilities Education.

The Office of Special Education at Mississippi Department of Education and external reviewers approved the proposal.

The Commission on Teacher and Administrator Education, Certification and Licensure and Development approved the proposal on September 6, 2013 to become effective September 2014.

PROPOSED NEW THIRD TRACK

Special Education Track (33 hrs) Mild/Moderate Disabilities

EDU 536 Classroom Management (3 hrs)

This course provides information to help teacher candidates develop pro-active strategies to manage the classroom environment and student behavior. Emphasis is placed on students' development of a personal and unique classroom management plan.

EDU 650 Tests, Measurements, and Evaluation (3 hrs) The study of the measurement and evaluation of student learning with both criterion and normreferenced procedures.

EDU 635 Internship I (3 hrs)

EDU 635 Internship II (3 hrs)

Six hours in increments of three. Students will be supervised by a university faculty member in an accredited school where they are employed. Students are required to attend scheduled seminars which will include research and discussion on current educational issues related to the classroom teacher.

EDU 572 Survey of the Exceptional Child (3 hrs)

A study of exceptionalities from the gifted to the profoundly handicapped.

EDU 660 Organizational Procedures for Special Education (3 hrs)

A study of the organizational procedures of special education as required by the Mississippi Department of Special Education and the legislative and court decisions associated with special education.

EDU 661 Intellectual Disabilities (3 hrs)

This course is an overview of intellectual disabilities including etiology and syndromes, theoretical research bases, and social, emotional, physical, and intellectual characteristics.

EDU 662 Teaching Individuals with Mild Intellectual Disabilities (3 hrs)

This course addresses basic assessment procedures, selection, and utilization of instructional methods, materials, and individualized programming for individuals with mild intellectual disabilities.

EDU 663 Learning Disabilities (3 hrs)

An overview of the field of learning disabilities including historical development, theoretical research bases, and social, emotional, physical, and learning characteristics.

EDU 664 Teaching Individuals with Learning Disabilities (3 hrs)

The course addresses basic assessment procedures, selection and utilization of instructional methods, materials, and individualized programming for individuals with specific learning disabilities.

EDU 665 Behavior Management (3 hrs)

Examines the laws, history, and prevalence of behavior disorders. Assessment instruments and procedures will be presented along with extensive coverage of intervention plans, curricula, and classroom management strategies.

Briefly state your request: Currently, the School of Education offers two tracks in the M.Ed. Art of Teaching: Elementary Education (4-6) and Secondary (7-12). With the State Board of Education's approval of Special Education for all Alternate Route programs, William Carey proposes to add the third track where a special education teacher candidate would earn 21 hours in Mild and Moderate Disabilities Education.

Briefly state your rationale: The School of Education has been aware of Alternate Route candidates adding Special Education through PRAXIS II. This in no way prepares a teacher candidate to serve the needs of our special populations. The Special Education Track will move candidates directly into our special education degree program.

<u>NOTE:</u> Program approval requests must be submitted no later than January 15 for upcoming fall implementation, and by July 15 for upcoming spring implementation. Please allow up to six months for standard review procedures and final approval. After TAP approves a licensed degree program or a new licensure requirement, the new program or requirements will be subject to approval by the Licensure Commission on Teacher and Administrator Education, Certification and Licensure and Development and the State Board of Education before candidates are eligible for Mississippi Teacher Licensure.
