22. Approval to begin the Administrative Procedures Act process: to Approve Regenerated Praxis Tests and Recommended Passing Scores as Recommended by the Commission on Teacher and Administrator Education, Certification and Licensure and Development

Background Information:

Educational Testing Service (ETS) has concluded several multistate standard-setting studies of Praxis II tests accepted by the Mississippi Department of Education (MDE). As a result of the studies, the current tests will be discontinued by ETS and replaced with the newly regenerated tests beginning in September of 2013 (see Table 1.1).

The Commission on Teacher and Administrator Education, Certification and Licensure and Development (the Commission) approved the recommendation to accept the regenerated Praxis Special Education: Teaching Students with Behavioral Disorders and Emotional Disturbances (0372) test and recommended passing score (cut scores) on November 2, 2012.

On May 3, 2013, the Commission approved the recommendation of ETS to accept the four newly regenerated Praxis II tests and passing scores (cut scores).
