18. <u>Report from the Commission on School Accreditation concerning the</u> <u>Commission's determination that an extreme emergency situation exists in</u> <u>the Claiborne County School District</u>

On September 10, 2013, the Commission on School Accreditation determined by Resolution that there is sufficient cause to believe an extreme emergency situation exists in the Claiborne County School District brought on by serious findings related to serious violations of accreditation standards and state law and a continued pattern of poor student performance which jeopardizes the safety, security, and educational interests of the children enrolled in the schools of this district.

<u>ORDER</u>

This matter came before a quorum of the Mississippi State Board of Education ("Board") present on August 15, 2013, for consideration of the recommendation of the Commission on School Accreditation ("Commission") that the Claiborne County School District ("District") should be assigned an accreditation status of WITHDRAWN NOT ACCREDITED.

The Commission conducted a show cause hearing which concluded on August 1, 2013, after which the Commission determined that the District should be assigned an accreditation status of WITHDRAWN NOT ACCREDITED. Per Miss. Code Ann. Section 37-17-6(11(a), the Commission's recommendation was forwarded to the Board for its approval, a copy of which is attached hereto as Exhibit "One" and incorporated herein by reference. After considering the Commission's recommendation, the Board finds that this matter should be remanded to the Commission with instructions that the Commission determine if an extreme emergency situation exists in the District that jeopardizes the safety, security or educational interests of the children enrolled in the schools per Miss. Code Ann. Section 37-17-6.

IT IS THEREFORE ORDERED that this matter be remanded to the Commission on School Accreditation for further proceedings by that body pursuant to Miss. Code Ann. Section 37-17-6 and other applicable laws and regulations to determine if an extreme emergency situation exists in the Claiborne County School District that jeopardizes the safety, security or educational interests of the children enrolled in the schools.

ORDER

Pending before the Commission on School Accreditation is the matter of Accreditation status of the Claiborne County School District (District). On December 11, 2012, the Commission scheduled a show cause hearing for March 6-7, 2013, when the District was required to show cause why the District's accreditation status should not be withdrawn. At the March 2013 hearing, the Commission with agreement of both the Mississippi Department of Education (MDE) and the District assigned an accreditation status of Probation. The Commission on School Accreditation (Commission) order further granted additional time in which the District could establish compliance and provide sufficient evidence and documentation to the MDE to verify compliance with the Mississippi Public School Accountability Standards 2012.

Pursuant to the subsequent order dated June 13, 2013, the Commission reconvened the show cause hearing on July 31, 2013, and August 1, 2013. At that hearing, the Commission heard and considered evidence and testimony by the MDE and the District. Having considered the evidence and arguments of counsel, the Commission hereby finds as follows:

- 1) The District did not provide sufficient evidence and documentation to demonstrate compliance with Standards 1, 2, 3, 9, 21, 23, 24, 27 and 35.
- 2) The District is not in compliance with Standards 8, 31, and 10.5 but the non-compliance is not the basis for the Commission's recommendation herein.

Based on these findings, the Commission hereby recommends to the Mississippi Board of Education that the District be assigned an accreditation status of WITHDRAWN NOT ACCREDITED.

WHEREAS, pursuant to Section 37-17-6 (12) (b) of the Mississippi Code of 1972, as amended, the Commission on School Accreditation met in a regularly scheduled meeting on September 10, 2013 to determine whether there was sufficient cause to believe that an extreme emergency situation exists in the Claiborne County School District which jeopardizes the safety, security, and educational interests of the children enrolled in the schools of this District; and,

WHEREAS, the Office of Accreditation, Mississippi Department of Education, presented certain information to the Commission regarding the Claiborne County School District's impairments related to serious violations of accreditation standards and state law and a continued pattern of poor student performance, a copy of which is attached as Exhibit "A" and incorporated by reference as though a part of this Resolution;

NOW, THEREFORE, the Commission on School Accreditation finds the following:

The Commission finds that there is sufficient cause to believe that an extreme emergency situation exists in the Claiborne County School District brought on by serious findings related to serious violations of accreditation standards and state law and a continued pattern of poor student performance which jeopardize the safety, security, and educational interests of the children enrolled in the schools of this District, and which, without intervention by the Commission on School Accreditation and the Mississippi Board of Education, could result in the continuation of an inadequate and unstable educational environment thereby denying the students of this District the opportunity to learn, to excel, and to obtain a free and appropriate public education.

BE IT KNOWN THAT the Executive Secretary of the Commission on School Accreditation is directed to immediately distribute a copy of this Resolution to the Interim State Superintendent of Education and the Mississippi Board of Education.
