B. Approval to award competitive grants for the Fresh Fruit and Vegetable Program

Purpose: Grants are awarded to elementary schools to purchase and serve fresh fruits and vegetables to students during the school day outside of the regularly scheduled meals.

Scope of Grant:

- Grant Period: October 1, 2013 - June 30, 2014
- Award Amount: \$2,148,371
- Method of Award: Request for Proposals

Funding Source: Federal (USDA, Section 19 of the National School Lunch Act)

Summary of Selection Process:

A competitive selection process was utilized to award the grants.

Scoring Criteria:

Federal regulations specify the following criteria:

- A. Be an elementary school
- B. Participate in the National School Lunch Program
- C. Have 50% or more of its students eligible for free/reduced price meals
- D. Be chosen based on the percentage of free/reduced price students with the highest priority given to schools with the highest percentages of low-income students, to the maximum extent possible
- E. Submit an application to participate
