22.A. Approval of request from Delta State University to modify its Elementary

Education program as recommended by the Commission on Teacher and

Administrator Education, Certification and Licensure and Development

Background Information:

Delta State University proposes to modify its elementary education program by removing MUS 320: Musical Skills and Concepts for Children and replace it with MAT 231: Geometry, Measurement and Probability. MAT 231 will further prepare elementary majors to teach mathematics in the elementary school.

With the implementation of Common Core in Mississippi, it is essential that candidates be prepared to teach mathematics. The addition of this course will provide candidates with an extensive knowledge in geometry, while maintaining the 124 credit hour limit for programs. The music content is addressed within other courses that provide instruction on music integration in the classroom. The requirement remains for candidates to complete six hours of fine arts with an elective (music or art equivalent) and ART 361: Art Content and Techniques.

The Commission on Teacher and Administrator Education, Certification and Licensure and Development approved the request on November 8, 2013.

Briefly state your request:

We request a modification to the current elementary education program of study. We would like to remove MUS 320 Musical Skills and Concepts for Children and replace it with MAT 231 Geometry, Measurement and Probability.

Briefly state your rationale:

MAT 231 is needed to further prepare elementary majors to teach math in the elementary school. With the implementation of Common Core in Mississippi, it is essential that our candidates are prepared to teach mathematics. The addition of this course will provide candidates with extensive knowledge in geometry. In addition, with the 124 hour limit for programs, it is necessary to eliminate an existing course and MUS 320 was chosen as other courses within the program allow for instruction in music integration in the classroom.

Please allow up to six months for standard review procedures and final approval. Rationale: We propose to revise the program of study for elementary education for a variety of reasons. As the current program of study shows, elementary education candidates take 9 hours of mathematics to include MAT 104 College Algebra, MAT 131 Number Systems of Arithmetic, and MAT 331 Mathematics through Problem Solving. MAT 231 Geometry, Measurement and Probability is currently offered as an elective. We believe that it is essential for all individuals seeking elementary certification to have extensive knowledge in teaching mathematics. With the implementation of Common Core in Mississippi, teachers will need a good foundation in teaching geometry. The addition of MAT 231 will ensure that DSU graduates have that foundation in geometry.

Because of the 124 hour limit to programs, it is necessary to remove a course from the current curriculum. MUS 320 Musical Skills and Concepts for Children was chosen to be removed as several of the current elementary methods courses allow instructors to teach candidates how to implement music into the curriculum. Candidates will still have six hours of fine arts in their program of study with a fine arts elective (music or art appreciation) and ART 361 Art Content and Techniques.

Candidates with a major in Elementary Education must complete all course requirements for the Interdisciplinary Program of Studies and must also have two areas of concentration consisting of 18 semester hours* in each area. This program of study will enable the Delta State University graduate to earn K-6 certification in the State of Mississippi. Candidates pursuing secondary level (7-12) certification must complete 21-hour concentrations leading to approved endorsements. A grade of C or higher must be earned in each course leading to endorsement. In order to complete the above requirements, it may be necessary to complete more hours than noted in the DSU catalog. The number of additional hours will vary depending on the concentration chosen.
