22.B. Approval of request from Delta State University for a secondary mathematics supplemental endorsement program as recommended by the Commission on Teacher and Administrator Education, Certification and Licensure and Development

Background Information:

Recently, the Mississippi Department of Education (MDE) amended its licensure policy for obtaining a secondary mathematics supplemental endorsement from any 21 hours of mathematics coursework to the completion of an approved program of study.

Delta State University proposes to offer a secondary mathematics supplemental endorsement program in addition to its current initial certification programs. This program will provide the advanced content preparation in mathematics needed to teach mathematics at the secondary level. In addition, the program is in line with the approved recommendations of the Mississippi Association of Mathematics Teacher Educators (MAMTE).

The Commission on Teacher and Administrator Education, Certification and Licensure and Development approved the request on November 8, 2013.

Briefly state your request: Delta State University would like to offer a <u>Secondary Mathematics</u> <u>Supplemental Endorsement</u> program in addition to our current initial certification programs. This program will provide the advanced content preparation in mathematics needed to teach mathematics at the secondary level. Because many teacher candidates wish to add an additional certification to their initial license, this program will ensure that those candidates seeking an add-on endorsement in mathematics will have knowledge of the necessary content in order to teach mathematics. The proposed program is in line with the recommendations made by the Mississippi Association of Mathematics Teacher Educators (MAMTE).

Briefly state your rationale: MDE recently amended its policy for obtaining a Secondary Mathematics Supplemental Endorsement from any 21 hours of mathematics coursework to the completion of an approved program of study. By completing a prescribed program of mathematics coursework, teachers will be better prepared to meet the higher expectations of the Common Core State Standards for Mathematics and to help the students in Mississippi schools to become college and career ready.

NOTE: Program approval requests must be submitted no later than January 15 for upcoming fall implementation, and by July 15 for upcoming spring implementation. Please allow up to six months for standard review procedures and final approval. After TAP approves a licensed degree program or a new licensure requirement, the new program or requirements will be subject to approval by the Licensure Commission on Teacher and Administrator Education, Certification and Licensure and Development and the State Board of Education before candidates are eligible for Mississippi Teacher Licensure.

Request: Approval to modify the current initial teacher education programs by adding a Secondary Mathematics supplemental with an approved 21 hour requirement.

Provide findings/comments/recommendations (if needed, please use additional space or provide an attachment):

- The requirement of passing the math content Praxis II exam is not necessary because just passing Praxis II will allow a student to add the math endorsement, therefore deeming the Program of Study unnecessary. **Recommendation: delete the Praxis II requirement.**
- The courses seem appropriate, however, there are pre-requisite courses listed (i.e. MAT 206) that are not described in your proposal, so we cannot evaluate whether students are likely to have had these pre-requisite courses. **Recommendation: provide courses titles with pre-requisite listings.**
- For the six-hour elective course options, it is repetitive to list MAT 322, MAT 405, MAT 415, and MAT 443 along with the statement "any other mathematics content courses at or above the 300+ level". Recommendation: delete the statement "any other mathematics content courses at or above the 300+ level" and add MAT 425 and MAT 442 to the list with a note that courses can only be counted once toward the program of study. This would mean that each individual student would be able to select the two elective courses from eight of the elective listings since they will take one of the nine as the Advanced Algebra course.

The program submitted by Delta State University will provide a candidate with the needed mathematics content to teach high school mathematics as outlined by the Common Core State Standards. I would like to point out a couple of items that may want to be considered by the University personnel and the Licensure Commission.

- 1. The program offers MATH 322 (Differential Equations) as a option for an elective course. The a pre-requisite for this course is stated to be MATH 253 (Calculus III) which is also listed as an elective option. Is it intended that if a student chooses MATH 322, that their other elective option must be MATH 253?
- 2. The program requires 24 hours of mathematics coursework. This is 3 hours (one course) more than the recommendation from MAMTE (21 hours). I do not disagree with the additional hours, but just wanted to bring it to the proposers' attention.
- 3. The option of adding a supplemental endorsement by successfully passing the Praxis II assessment continues to be an option through the MDE. With that policy, I do not feel that the requiring a passing score on the Praxis II in addition to the 24 hours of mathematics is necessary. Potentially, it would prevent some students from completing the endorsement program if they could get the endorsement by only taking the assessment. I would recommend removing that requirement from the program, due to the current MDE policy.
