07. <u>Approval to award competitive grants for the Mississippi Community Oriented</u>
Policing Services in Schools (MCOPS) grant program

<u>Purpose</u>: During the 2013 legislative session Section 37-3-82, Mississippi Code of 1972, Annotated, established the Mississippi Community Oriented Policing Services Grant for the utilization of school resource officers (SRO) within the K-12 education system. The bill allocates up to \$10,000 per officer to pay the salary and benefits of school resource officers. The funding must be matched from local funds on a 50/50 matching basis.

Scope of Grant:

• Grant Period: February 21, 2014 - June 30, 2014

Award Amount: \$630.000

• Number of Awards 63 Officers (Attachment 1)

24 School Districts

Grant History:

In an effort to award the maximum number of grants the Mississippi Department of Education has provided multiple opportunities for school districts to apply. The State Board of Education approved in October 2013 awarding \$1,570,000 for 157 officers (Attachment 2) in 50 school districts. This grant period was for October 18, 2013 – June 30, 2014.

<u>Funding Source</u>: State funds, Section 37-3-82, Mississippi Code of 1972, Annotated

This a one-time allocation provided by the Mississippi Legislature. Additional funding would be contingent upon approval by the Mississippi Legislature.

Summary of Selection Process:

A competitive grant selection process was utilized to award the grants.

MCOPS grants were awarded based on the personnel needs as determined by the local school district.

All applications received by the Mississippi Department of Education have been approved for funding.

Scoring Criteria:

- A. Description of Need (i.e., results from previous assessments, statistical data)
- B. Plan of Action (i.e., how will the SRO be utilized, proposed activities)
- C. Current Staff and Students (i.e., does the school have an SRO, student population, grades served)
- D. Current Limitations (i.e., limitations that exist to current law enforcement, lack of personnel, multiple schools, excessive response time)
