# Background Information:

The Office of Career and Technical Education is requesting approval of four new and updated career and technical education (CTE) 900 level endorsement codes. Since the inception of the CTE high school redesign program, all CTE license endorsement codes have been 900 level licenses.

On November 8, 2013, the Commission on Teacher and Administrator Education, Certification and Licensure and Development approved the new CTE endorsement codes. The new and updated endorsement codes are:

- 948 Family and Consumer Science (non-education)
- 949 Family and Consumer Science (education)
- 953 Career Pathway: Lodging, Hospitality and Tourism Management
- 961 Career Pathway: Health Sciences (to be deleted June 2015)
  Career Pathway: Healthcare and Clinical Services (effective July 2014)

# Commission on Teacher and Administrator Education, Certification and Licensure and Development

The Office of Career and Technical Education requests the Commission on Teacher and Administrator Education, Certification and Licensure and Development to consider new and updated educator endorsements for academic year 2014-2015.

948 Family and Consumer Science (non-education) – The courses to be taught under this educator endorsement have been modified and updated and are ready for implementation. To assure greater effectiveness, the requirements for teachers have been modified. When approved, 948 will replace 321 Vocational Home Economics/Family and Consumer Sciences (non education).

949 Family and Consumer Science (education) - The courses to be taught under this educator endorsement have been modified and updated and are ready for implementation. To assure greater effectiveness, the requirements for teachers have been modified. When approved, 949 will replace 322 Home Economics/Family and Consumer Sciences (education).

953 Career Pathway: Lodging, Hospitality and Tourism Management – The curriculum for lodging, hospitality and tourism management has been updated and the revised sequence of courses has been placed in a new career pathway. To ensure greater effectiveness, the requirements for teachers of this new career pathway have been modified. When approved, 953 will replace 311 Lodging and Hospitality.

961 Career Pathway: Health Sciences (to be deleted June 2015) <u>and</u> Career Pathway: Healthcare and Clinical Services (effective July 2014) – The curriculum for health sciences has been updated and converted to healthcare and clinical services. The revised sequence of courses has been placed in a new career pathway titled healthcare and clinical services that will replace health sciences. When approved, 961 will drop health sciences and be known as healthcare and clinical services.
