**OFFICE OF DISTRICT ACCREDITATION**

01. Action: Approval of the Corrective Action Plan for districts assigned a PROBATION or WITHDRAWN status in accordance with Accreditation Policy 2.8.1 [Goals 1, 2, 3, and 4 – MBE Strategic Plan]

Background Information: In accordance with Accreditation Policy 2.8.1 of the *Mississippi Public School Accountability Standards, 2015*, a school district that has been assigned a PROBATION or WITHDRAWN accreditation status must submit a Corrective Action Plan (CAP) with defined timelines in which to correct the district's deficiencies. In accordance with Policy 2.8.1, the State Board of Education implements the program of development in each district in accordance with Section 37-17-6(11), *Mississippi Code of 1972*, as amended.

The districts submitted the CAPs to the Mississippi Department of Education within sixty (60) days of notification as required. Each program office has reviewed the applicable section of the CAPs and has approved the provided corrective actions and timelines.

The Commission on School Accreditation met in a special-called meeting on Tuesday, March 15, 2016, to approve the CAPs for the sixteen (16) districts assigned a PROBATION status.
