Board appointments

The Mississippi School for Mathematics and Science (MSMS) advisory board is comprised of eleven (11) members. Membership includes a secondary school principal, a secondary school counselor, a district superintendent, a middle school/elementary representative, an officer of the MS Association for Gifted Children, a non-public/parochial school representative, a MSMS parent of a junior, and four (4) laypersons in accordance with the MSMS Operating Procedures. Each member serves a term for three (3) years with the exception of the parent member who shall serve for the two (2) years that the child remains a student. With the exception of the parent member, members may be reappointed for a single second term. Appointments are made by the State Board of Education from recommendations by the State Superintendent of Education.
