<u>Scope of Project</u>: The contract renewals include services for Fiscal Year 2019. The contractors will conduct a variety of monitoring activities to ensure local school districts comply with the requirements of the *Individuals with Disabilities Education Act* (IDEA) and State Board Policy 74.19 for the second (2) year of a three (3) year procurement including but not limited to, the following:

- Utilizing the Office of Special Education (OSE) monitoring tools and protocols in the review of Individualized Education Programs(IEPs), cumulative records, assessment and eligibility documentation; to develop comprehensive reports;
- Reviewing Teacher Support Team file, disciplinary documentation, Functional Behavioral Assessment(FBA), Behavior Interventions (BIPS, and other applicable student files;
- Documenting on the monitoring protocols, the status of the district's compliance for each regulatory item noted;
- Documenting through the collection of evidence the district's compliance/noncompliance by obtaining copies of record/files and providing these to the OSE team leader to be maintained as part of the OSE's monitoring files;
- Assisting the OSE team leader with the refinement of or clarification of findings in the monitoring report.

Renewal for contracts for year three will be determined annually and shall be contingent upon the successful completion of the preceding year's contacts and the availability of funds. Personnel associated with these contracts are not former Department employees or related to any Department employees. The contractors with an asterisk by their name are PERS retirees.
