04.J. <u>Action: Contract with selected vendor for the operation of a supplemental Mathematics digital subscription for grades K - 8</u> [Goals 1, 2, and 6 - MBE Strategic Plan]

Scope of Project: When schools opened in the fall of 2021, many students entered with unfinished learning. Survey data collected from the *Equity in Digital Learning Act (ELDA)* Needs Assessment identified digital curriculum, supplemental subscriptions, and training supporting blended learning as a need for teachers and students. This contract will provide equitable access for students and their families to engaging supplemental digital subscriptions and related training for teachers that complement adopted High-Quality Instructional Materials (HQIM) in mathematics.

The contractor will provide the following as described in the Request for Quotes:

- Grades K 8 digital supplemental instructional materials to support the delivery of effective Mathematics Instruction and to enhance the availability of elementary and middle school mathematic resource, tools and manipulatives for students and teachers.
- The requested tools must adapt to individual learning, ensure equity for students with special needs, English learners and other disenfranchised students, while offering actionable data and reporting.
- The contractor will be responsible for the total operation, administration, and management of the supplemental subscription including registration, enrollment, content, and providing teachers online profession development.
- Other responsibilities will be the daily operation of the supplemental digital material, providing technical and customer support, learning management system, and troubleshooting.

Renewal of contract for years two (2) through three (3) shall be contingent upon the successful completion of the preceding year's contract and the availability of funds. Personnel associated with this contract are not former Department employees or related to any Department employees.

Scope of Contract:

• Term of Contract: December 16, 2021 – December 15, 2024

(liquidation by December 30, 2024)

• Amount to be Awarded: \$9,450,000

Method of Award: Request for Quotes

Funding Source: Federal ESSER II/ARP Funds

<u>Summary of Selection Process</u>: A competitive selection process was utilized to award contracts. The evaluation team scored each submission based on the technical qualifications, overall experience in performing the required services, and the bonus opportunity. Once the technical scores were computed, the budget points were formulated by using the ITS Cost Formula. The two sets of points were combined to determine the winner of the contract.

A. Technical Qualifications

- B. Plan for Performing the Required Services
- C. Budget
- D. Bonus
