E. <u>Approval of educator preparation programs as recommended by the Commission on Teacher and Administrator Education, Certification and Licensure and Development</u>

Background Information: In accordance with Miss. Code Ann. § 37-3-2(1) there is established within the MDE the Commission on Teacher and Administrator Education, Certification and Licensure and Development (Licensure Commission). It shall be the purpose and duty of the Licensure Commission to make recommendations to the Mississippi Board of Education regarding standards for the certification and licensure and continuing professional development of those who teach or perform tasks of an educational nature in the public schools of Mississippi. On September 9, 2022, the Licensure Commission granted approval of the following educator preparation programs as recommended by the Division of Educator Preparation. Full documents pertaining to each program review are available upon request.

Alcorn State University modification to existing master's degree in School Counseling to meet MDE program review requirements and standards set forth by the Council for the Accreditation of Counseling and Related Educational Programs (CACREP) to include 60-hours of course credits. Proposed changes will have an effective date of January 1, 2023.

Blue Mountain College modification to existing bachelor's degree in Music Education. Additions to program to include additional hours of Physical/Lab Science; EDU 326 Reading in the Academic Disciplines; MUS 100 Recitals and Activities. Removing from the program a three-hour requirement for minor ensemble participation. The following courses were reclassified to meet college core requirements: MUS 274 Music Literature, MUS 360 History of Western Music, and EDU 400 Theories of Learning. Proposed changes will have an effective date of January 1, 2023.

Mississippi State University modification to existing master's degree in Educational Leadership. Requesting a reduction of hours from 33 to 30, removing EDF 8443 Evaluation of School Programs. Proposed changes will have an effective date of January 1, 2023.
