04.A. Action: Award competitive grants for the State Invested Pre-Kindergarten Program [Goal 3 – MBE Strategic Plan]

Background and Purpose: The Mississippi Legislature, in 2022, appropriated new state funding to provide public schools a grant opportunity to implement pre-K programs. The purpose of these grants is to provide funding to support highquality pre-Kindergarten programs for four-year-old children in districts that are not part of an Early Learning Collaborative. The new pre-K programs will meet all ten National Institute for Early Education Research (NIEER) benchmarks: use of early learning standards, curriculum supports, teacher degree, teacher specialized training, assistant teacher degree, staff professional development, maximum class size, staff-child ratio, screenings and referrals, and a continuous quality improvement system. Partnerships with local child care centers or Head Start grantees are not a condition for receiving these grants, but is incentivized as a criterion for extra points in the application process.

Continuation of this grant for years two (2) through three (3) shall be contingent upon the successful completion of services from the preceding fiscal year's grant and the availability of funds.

 Grant Period: November 14, 2022 – June 30, 2025

(With a liquidation period ending July 12, 2025)

Award Amount: \$15.450.000

 Method of Award: Request for Application

Funding Source: State funds

Summary of Selection Process:

A competitive grant selection process was utilized to award the grants.

Scoring Criteria:

- A. Eligibility
- Need for Pre-K B.
- **Program Requirements**
