Minutes of Mississippi Board of Education Meeting

November 8, 2022

The members of the Mississippi Board of Education met in a Special-Called Board meeting at 1:00 p.m. on Tuesday, Novemer 8, 2022 for the purpose of interviews of semi-finalists for the State Superintendent. The location of the meeting was the offices of Butler Snow at 1020 Highland Colony Parkway, Ridgeland, MS 39157. Board members present were: Ms. Rosemary G. Aultman, Mr. Glen V. East, Dr. Karen J.
