Minutes of Mississippi Board of Education Meeting

February 17, 2022

The members of the Mississippi Board of Education met in a Board meeting at 10:00 a.m. on Thursday, February 17, 2022, via video means pursuant to Miss. Code Ann. § 25-41-5 for the purpose of conducting the Board meeting.

The Board made this meeting available to the public via live stream. Board members present in the 4th Floor Boardroom at the Central High School Building, 359 North West Street, Jackson, Mississippi included: Ms. Rosemary G. Aultman, Dr. Wendi Barrett (Biloxi, Mississippi), Dr. Angela Bass (Jackson, Mississippi), Mr. Glen V. East, Dr. Karen J. Elam (Oxford, Mississippi), Mr. Bill Jacobs, Dr. Ronnie L. McGehee (Nashville, Tennessee), Mr. Matt Miller, and Ms. Mary Werner (Saltillo, Mississippi). Student Representative: Ms. Amy Zhang (Columbus, Mississippi). Student Representative absent: Ms. Micah Hill. Dr. Carey M. Wright was also present at the 4th Floor Boardroom at the Central High School Building, 359 North West Street, Jackson, Mississippi.

- Ms. Rosemary G. Aultman called the Board meeting to order at 10:04 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting through video means in accordance with Miss. Code Ann. § 25-41-5.
- II. Mr. Matt Miller led the Pledge of Allegiance and Mr. Glen V. East gave the Invocation.
- III. On a motion by Mr. Bill Jacobs, seconded by Mr. Matt Miller, the Board voted unanimously to approve the January 20, 2022, Board meeting minutes.
- IV. On a motion by Mr. Glen V. East, seconded by Ms. Mary Werner, the Board voted unanimously to approve the agenda as presented.
- V. Recognition Ceremony

2021 Mississippi History Teacher of the Year

¹ Due to the impact of COVID-19 (coronavirus) and the recommendations of the CDC and the Mississippi Department of Health, social distancing is encouraged and capacity in the Boardroom is limited. To protect the public health, the State Board of Education met via teleconference and video means and the meeting was available to the public via video means (live stream). The SBE exercised their authority granted by the Governor in his Proclamation of a State of Emergency. *See* Miss. Code Ann. § 33-15-31.

- VI. Dr. Carey M. Wright gave the following report as the State Superintendent of Education:
 - Dr. Wright stated the Utah House and Senate Education Committees invited her to testify virtually before both committees about developing a literacy bill like Mississippi's and they wanted to hear about MDE's strategies and how MDE implemented the bill.
 - Dr. Wright stated that she, Mr. Pete Smith, and Dr. Felicia Gavin testified before the House Appropriations Committee about the Board's Legislative Priorities and the education bills during the Legislative session.
 - Dr. Wright stated the Hunt Institute from North Carolina invited her to serve on a panel about teacher residence and it is called teacher residence return on investment: a pathway that prepares effective and diverse teachers who stay. Dr. Wright stated MDE has implemented a strong teacher residence program and a news release will be coming out soon.
 - Dr. Wright stated that she appeared on the Paul Gallo Radio Show.
 - Dr. Wright stated that she and Mr. Smith met yesterday with the Black Caucus, and they had a lot of questions as they are considering some bills moving through the session.
 - Dr. Wright stated that she met with the Teacher Advisory Council, a group of about 400 teachers, and they are forthcoming with information about what they see and what their needs are. Dr. Wright stated that it comes back to the Executive Leadership Team, and we respond to what they want and need.
 - Dr. Wright shared with the Board resources that have been created. Dr. Wright thanked Dr. Marla Davis and her team for the Middle School Transition Toolkit. Dr. Wright stated that this is for districts and gives them some ideas for students transitioning from elementary to middle school and transitioning from middle to high school. Dr. Wright stated it has a lot of good ideas.
 - Dr. Wright passed out a listing for all the mental health training that has been scheduled. Dr. Wright stated that MDE is hearing a lot from superintendents, principals, the Teacher Advisory Council, and the Student Advisory Council about a lot of students and adults carrying a lot of stress on them. Dr. Wright stated MDE has been ramping up professional development where mental health is concerned. Dr. Wright stated that list shows the topics, dates, and times for the training that is scheduled.
 - Dr. Wright stated that the teacher residence program started with funding from Kellogg and when that funding ran out the ESSER funding came in. Dr. Wright stated that in December the Board approved to award over \$8 million to five universities to establish the teacher residency program. Dr. Wright stated this will be for about 200 people and it pays for tuition, expenses, testing fees, books, mentor stipends, and this will be tremendously helpful as they are working toward becoming a teacher. Dr. Wright stated the goal is to get these people trained, get them the degrees they need in either elementary or special education, and put them in the

- classrooms. Dr. Wright stated that this is a great way for Mississippi to continue to grow our own.
- Dr. Wright stated that the MDE held the Social Studies framework hearing in January, and she thanked Mr. Mike Kent for serving as the hearing officer. Dr. Wright stated that MDE is in the process of gathering all the data, looking at all the responses, and addressing them. Dr. Wright stated that the framework will come back to the Board in March and the Board will be able to see with input that MDE received and what MDE does with the inputs and what the MDE recommendations will be.
- VII. Ms. Rosemary G. Aultman, Chair of the State Board, gave the following report.
 - Ms. Aultman stated that she, Dr. Wright, Ms. Sonya Amis, and Dr. Robert Hull from the National Association of State Boards of Education (NASBE) have finalized the topics for the Board Retreat which will be held on February 25, 2022.
 - Ms. Aultman stated that Mr. Omar Jamal, former student representative, is attending Vanderbilt and is on the Dean's List. Ms. Aultman stated that he will be going to Greece to study abroad and has joined some organizations on campus. Ms. Aultman stated that he has not declared a major yet, but he is loving college.
 - Ms. Aultman stated that Dr. Wright will be honored at a reception and program as one of the 50 Most Influential People in Mississippi. Ms. Aultman stated that the Board is proud of Dr. Wright and honored to work with her. Ms. Aultman stated that Dr. Wright has changed the trajectory of education in Mississippi.

VIII. Report of Student Representative

Ms. Amy Zhang stated that she will be talking about Dr. Wright's Student Advisory Council that met earlier this month. Ms. Zhang stated that a PowerPoint presentation was presented, and the students divided into four different work groups. Ms. Zhang stated that slides were presented on ACT preparation included: ACT preparation, career academies, life skills, civil rights education, mental health training and support, special education, bullying, and LGBTQ safety, educator diversity, and sex education. Dr. Wright was out sick and could not attend the meeting but MDE experts Ms. Wendy Clemons, Dr. Armerita Tell, Mr. Joe Goff, Dr. Courtney Van Cleave, and Mr. Scott Clements stepped in to help present. Ms. Zhang stated that after the presentation the students separated into breakout rooms to form four different work groups where they would work with the rest of the group to start planning a presentation on their topic. Ms. Zhang stated the first group was the mental health group that she helped with. Ms. Zhang stated that the group discussed students' experiences with mental health support in schools, interactions with school administrators, and counselors, pressures and the type of help given to high achieving students in metal health days. Ms. Zhang stated that they have had a second meeting

already and plan to meet once or twice a week. Ms. Zhang stated that next work group is the life skills group, and they plan to cover skills such as culinary skills, home maintenance, automotive, basic electrical skills, social skills, and public speaking, managing business, gun safety, mental health, and critical thinking. Ms. Zhang stated that they are currently assigning people to every topic, and they have started researching and working on their slides. Ms. Zhang stated the third group is the ACT prep group and they have held a second meeting where they discussed their plans and ideas such as incentives for students in schools and districts to offer ACT prep, increasing the scope of ACT prep, improving classes, and disparities between different schools. Ms. Zhang stated they have been brainstorming and researching solutions to all the problems that they have discussed. Ms. Zhang stated the last group is the civil rights education group. They held a meeting earlier this week and discussed critical race theory in how the new law will affect Mississippi's high school civil rights education. Ms. Zhang stated they also discussed ways to improve the curriculum like offering African American Studies as an elective focusing on important figures within the civil rights movement and comparing what different schools are teaching. Ms. Zhang stated that in conclusion she thinks that the meeting went well, and students have adjusted to holding these meetings virtually and she thinks it went a lot smoother than it did last year. Ms. Zhang stated she is excited to see what the work groups create within the next two months, and she really loves the opportunity to talk to all these student leaders from all over the state and to help facilitate their conversations between them as well and in April when they present their final presentations, I think the Board will really be impressed.

IX. Mr. Glen V. East, Chair of the Academic Achievement PreK-12/Early Childhood Subcommittee, stated that the subcommittee met yesterday afternoon via Teams. Mr. East stated the Middle School Transition Toolkit came before the Subcommittee and it is an outstanding document. Mr. East stated that on the agenda today is the tutoring piece and it should be very powerful for every family in the state of Mississippi.

Dr. Karen J. Elam, Chair of the Educator Quality Subcommittee, stated they met yesterday afternoon and all members were present. Dr. Elam stated that Dr. Debra Burson informed the Subcommittee about continued work beyond the SREB leadership. Dr. Elam stated that Dr. Burson shared that two staff members will lead the Governor's Human Capital Task Force work and they had their first meeting and are getting organized to meet on a regular basis and build upon the SREB document put together for the Governor and how the agency is going to move forward with those plans.

Ms. Aultman, Chair of the Legislative Subcommittee, stated they met this morning and Mr. Pete Smith updated them on the bills that are dead and the bills that are still alive that are of interest to education. Ms. Aultman stated that the teacher pay raise bill is still alive and moving through the process. Ms. Aultman

stated that the deadline to come out of committee is March 1. Ms. Aultman thanked Mr. Smith and others for all their work with the Legislature and for keeping the Board updated.

Dr. Angela Bass, Chair of the School Performance and Accountability Subcommittee, stated they met this morning and discussed some agenda items that will be discussed today. Dr. Bass stated they discussed a program evaluation report about the prekindergarten infrastructure development grant and there were some important findings about the importance of having some PreK coaches on the ground and we are really excited about what the preliminary findings are saying. Dr. Bass stated they approved appointments to the Ad Hoc Screening Committee for the recruitment of the 2022 – 2024 student representative that will be coming on Board once Ms. Amy Zhang graduates and goes on to her next academic journey.

The decision of the Commission's Hearing Subcommittee shall not be disturbed on appeal if supported by substantial evidence, was not arbitrary or capricious, within the authority of the Commission, and did not violate some statutory or constitutional right. It is the decision of this State Board of Education to:
