G. Approval to revise Miss. Admin. Code 7 – 4: Part 4: Licensure Guidelines K-12, to amend criteria regarding educator licensure preparation and other programs completed outside the state of Mississippi

(Has cleared the Administrative Procedures Act Process with public comments)

Background Information: The Office of Teaching and Leading, Division of Educator Licensure continues to review all guidelines pertaining to the issuance, renewal, and reinstatement of an educator license to ensure that all requirements remain relevant to the contextual framework of present day. On January 21, 2021, the State Board of Education granted approval, as a necessary protection for all Mississippi's prospective and practicing educators seeking to obtain initial licensure in the state of Mississippi by way of completion of a program outside of Mississippi, to require that such candidates shall first be licensed in the state where the preparation occurred. Upon obtaining the out-of-state license, the candidate shall submit an application with required supporting documentation to the MDE Division of Educator Licensure for the purpose of determining eligibility to obtain a Mississippi license via Reciprocity guidelines in effect on the date the complete application is received by the MDE.

While the implementation of this policy has helped to improve the Mississippi resident's experience with institutions outside of Mississippi over the past two years, an unintended consequence is the negative impact it is posing for local school districts that recruit and employ educator preparation program completers coming to Mississippi from another state attempting to use their CAEP accredited/state approved program alone. The policy as currently written, is further hampering the state's ability to address the shortage long faced not only in teaching fields but also in other hard-to-staff supplemental service provider areas such as Professional School Counseling among others.

On September 14, 2023, during a special-called meeting, the Commission on Teacher and Administrator Education, Certification and Licensure and Development granted approval to amend requirements related to licensure-track preparation and other programs completed outside the state of Mississippi.

The temporary rule and final action are necessary to implement the policy revisions immediately upon its filing with the Secretary of State in accordance with Miss. Code Ann. § 25-43-3.113(2)(b)(ii). See also Miss. Code Ann. § 25-43-3.108. For a

rule to become effective immediately upon its filing, the Board is required to make a finding that the rule only confers a benefit or removes a restriction on the public or some segment thereof.

The public comment period was open from September 18, 2023, through 5:00 p.m. on October 27, 2023, with public comments received. Based on the comments received, the MDE recommends no changes to the proposed policy.

Document Submission

All applications and supporting documentation must be submitted electronically through the educator's assigned Mississippi Educator Career Continuum Archive system (MECCA) account. No documents should be submitted via postal mail. Licenses will be valid from the day the completed application packet is received and validated by the Division of Educator Licensure. A completed application packet includes the licensure application and all supporting documentation required for your requested license type. Applications that are submitted without supporting documents will be considered incomplete and the educator will be emailed a "requirements" letter stating which documents are needed to process the licensure request. Please review the Licensure Application Checklist to identify the documents required for obtaining licensure in your desired area of certification: https://www.mdek12.org/OEL/Licensure-Application-Checklist.

Transcripts must be submitted electronically directly from the institution and licensure test score reports directly from the appropriate testing company. All original documents to be used as part of the licensure application review process must be scanned and then uploaded to your MECCA system account as a Portable Document Format (PDF) file, captured using the camera on your cellular device, or by utilizing free software applications available for download that are compatible with most smartphone models. When capturing a photograph of the document to be submitted, please be sure to remove any content and/or extra spacing that is not part of the document. This should be done prior to document upload to not obstruct access to information pertinent to reviewing and processing your licensure request.

All documents submitted to the Division of Educator Licensure become the property of the Mississippi Department of Education and will not be returned to the applicant, unless otherwise stated, nor will the Department provide copies of the documents to the applicant or third parties. Only the following documents will be duplicated and returned to the applicant if submission is required: Original – Out-of-state license, Professional Association Card, Marriage License, Birth Certificate, and Licensure Test Score Report. It is the responsibility of the educator to obtain copies of documents prior to submission to the Division of Educator Licensure.

SPECIAL NOTE

A grade of "C" or higher must be obtained on <u>all</u> coursework taken for renewal of license, reinstatement of license or the adding of supplemental endorsements. This includes all coursework outlined on planned programs required to convert a special license to a standard license.

Acceptable Degrees or Coursework for Licensure

The Division of Educator Licensure accepts degrees or coursework from any nationally or regionally accredited institution. An institution's accreditation status can be verified using the United States Department of Education website (https://www.ed.gov/accreditation) or the Council on Higher Education Accreditation website (https://www.chea.org/). Section 37-3-2 of the Mississippi Code authorizes the Certification Commission and State Board of Education to approve all educator preparation programs offered by Mississippi-based educator preparation providers for any license-type offered in Mississippi. The Commission does not approve programs completed in other states.

Licensure Preparation and Other Programs Completed Outside the State of Mississippi

Prospective and practicing educators seeking to obtain initial licensure in the state of Mississippi by way of completion of a traditional state approved or nationally accredited licensure-track teacher, administrator, certain supplemental service provider, and supplemental endorsement preparation program from a regionally/nationally accredited institution of higher education program outside of Mississippi, shall first obtain Institutional Program Verification (IPV) from the educator preparation provider be licensed in the state where the preparation occurred. Upon obtaining Institutional Program Verification (IPV) using the form established by the MDE Division of Educator Licensure the out of state license, the candidate shall submit an application with required supporting documentation to the MDE Division of Educator Licensure for the purpose of determining eligibility to obtain a Mississippi license via Reciprocity guidelines in effect on the date the complete application is received by the MDE. Educators that complete a nontraditional licensure-track program outside of Mississippi shall first be licensed in another state and seek to obtain a Mississippi license via Reciprocity guidelines in effect on the date the complete application and required supporting documentation is received by the MDE.

I am writing regarding the APA Proposed revisions of Miss. Admin. Code 7-4: Part 4: Licensure Guidelines K-12 regarding requirements for applicants who completed training programs outside the state of Mississippi.

As a 215 licensed speech-language clinician and nationally certified speech-language pathologist through the American Speech-Language-Hearing Association, I fully support this revision. By accepting applications from individuals who obtained a degree outside the state of Mississippi, we are removing a barrier to recruitment of highly qualified candidates in teaching and speech-language pathology to our state. The requirement of being licensed in the state where the degree was obtained created an undue burden on candidates who actively wanted to be employed in Mississippi school districts. Additionally, as speech-language pathologists, this created a barrier to recruiting them to work in school districts, as they were able to obtain a department of health license to practice in private practice or healthcare settings with the same degree.

Thank you for responding to the requests of school districts, SLPs, and other applicants who wished to work in Mississippi but couldn't because of this requirement.

Dear Dr. Murphy,

Please accept this as my comments regarding the change to licensure requirements for applicants who graduated from a program outside of the state of Mississippi. I have been a school based SLP for over 18 years and worked for the state of MS for 24. I can see retirement coming over the horizon. This year I accepted the position of SLP Coordinator for my district. Though it has been challenging I'm proud to be in a position to help the SLPs in my district and bring new ones into the fold.

I was contacted by an ASHA certified SLP who currently works in a skilled nursing facility and is wanting to come work in a school. As you probably know, school districts are in desperate need of SLPs among other personnel. She has not held MDE licensure because this will be her first time working in a school. I instructed her on how to apply for her license and was prepared to interview her to fill one of the many positions we currently have available in our district. However, image my surprise when she was informed that she had to obtain her licensure through reciprocity because she graduated from a Communication Disorders program in Louisiana! I contact Mrs. Laney just to get clarification on why this was the case. She did provide me with an explanation and the rationale behind it. And although I understand that rationale, I do not agree with it for a few reasons. First, there are a limited number of SLP graduate programs in our state with a very limited number of spaces for students. I Completed my Master's Degree at Southern University A&M College in Baton Rouge, Louisiana because I did not get accepted into a program here at home. Luckily I was able to come back and begin my career in my home state. Thankfully we have more now than when I was applying, but it's still very limited. Second, I especially do not agree with this rule in the case of ASHA certified SLPs. The American Speech Language Hearing Association puts many steps and safeguards in place to make sure that certified SLPs are fully trained and prepared to work in our field. They begin with stringent accreditation requirements for programs, over 300 required hours of clinical practicum to graduate besides all of the classwork, passed the Praxis 2 ASHA exam, and finally a nine month supervised certification year after graduation. To say once an SLP receives their C's they have been through the ringer is an understatement.

I said all of that to say, while I'm very excited about the proposed changes to this licensure requirement, I suggest it go a little further for ASHA certified SLPs. If an SLP has their certification, they should be able to get MDE certification without additional requirements. They have completed a long arduous process and are indeed ready to serve the children of Mississippi. I could see this change being applied to new Masters' graduates, but those of us that have completed the process should be allowed to obtain our licensure. We've definitely earned. It.

As you know, educators are retiring at record numbers. I'm proud to say I'm very close to reaching that milestone. The need for SLPs will not lessen anytime soon. I truly feel it will only get bigger as experienced clinicians as myself decide to retire. Making it easier in a safe manner for new SLPs to start their career and begin the work we've started will be essential.

Thank you for taking the time to re-evaluated this matter, and for allowing me the opportunity to voice my opinion and concern.

Dear Mississippi Department of Education,

Thank you for the opportunity to comment on the proposed revision of Miss. Admin Code 7-4: Part 4: Licensure Guidelines K-12. Working as the liaison between our district and the MDE's licensure department, I know our district has experienced difficulties with teacher candidates that completed a teacher preparation program outside of the state of Mississippi obtaining a license in Mississippi. This has placed an immense burden on the district with the teacher shortage we are all faced with in Mississippi. I am in favor of the proposed revision to this law.

DeSoto County, MS shares a border with Memphis, Tn where many of our residents work and attend college. Our district has hired several new teachers that graduated from The University of Memphis, the closet public university to our district, who live in DeSoto County and desire to work in the community in which they live. Since the policy change that took effect on February 22, 2021, all teacher candidates must first be licensed in the state where the preparation occurred has presented roadblocks in reciprocating a license to Mississippi. One of the biggest issues is Tennessee's first issuance of a teaching license is for three-years. Although, the prospective educator completed all the traditional route program's requirements, Mississippi will not reciprocate a three-year license. The graduates that we have been fortunate to hire from universities in Tennessee, had to go through a neighboring state to reciprocate their three-year license to a five-year license. Only then were they able to reciprocate that five-year license to Mississippi license. We have had to request a special, one-year license for others while they try to get their license reciprocated to Mississippi.

The other big issue is new graduates that completed a traditional route program from other states, inperson or online, are having difficulties in obtaining a license in that state if they are not going to teach there.

To whom it may concern,

I was asked to send in a public statement for the board on the positive effects a change in the reciprocity licensure requirements will have on out of state SLP graduates.

As lead SLP of a large school district in MS, the current policy has greatly impacted our ability to hire qualified SLPs. Last spring, we were excited to offer a job to a local SLP, contingent on MDE licensure. This SLP wanted to transition to schools after 12 years in a hospital setting. She had a Master's degree from University of Memphis, an esteemed SLP graduate program. This SLP was also bilingual, which would have been a rare asset to our team. Ultimately, she was unable to obtain an MDE license due to the reciprocity policy, and we were unable to hire her. In her case, she was expected to obtain a license in TN first, then gain MDE license through reciprocity. TN would only offer her a temporary license which would be upgraded to an "advanced professional license" after 3 years of school work within the state of TN. This SLP had no intention of living or working in TN, and with the reciprocity policy in place, she would never be able to obtain MDE licensure aside from moving her family out of Mississippi for a period of time. Because that is unreasonable, she gave up on her aspirations to work for public schools.

Many Mississippi SLP undergraduates apply to out of state graduate programs due to the competitive nature of admissions and small cohort size. Oftentimes they return to Mississippi to work after their schooling is complete. If the policy is amended, we will be able to recruit and hire more of these SLPs, which will have a positive impact throughout the state! Thanks for considering my experience/opinion on this matter!

Dear Dr. Murphy:

I recently have been made aware of the action considered by the Mississippi School Board of Education with regard to Miss. Admin. Code 7-4: Part 4: Licensure Guidelines K-12, which would amend the requirements related to licensure-track preparation and other programs completed outside the state of Mississippi. As I understand it, the revision of this code would result in out-of-state applicants not being required to have full licensure in Mississippi of an EDLD program before MDE would reciprocate their license. The purpose of this letter is to express my strong opposition to the reversal of the out-of-state licensure requirements. Furthermore, I am well aware of the challenges associated with hiring speech pathologists and special education teachers, but my concerns of lowering these standards far outweigh the potential benefits in my opinion. Please allow me to explain:

- 1. There is an excess of certified administrators already endorsed within our state. As a matter of fact, there are enough candidates to fully staff every leadership position three times over.
- 2. Most of the out-of-state EDLD programs fail to include the PSEL standards which drive the SLLA assessment.
- 3. Online programs are available through any of the nine Mississippi EDLD programs; therefore, there is no need to participate in a program that does not address the PSEL standards and certainly no need to lessen the requirements for endorsement eligibility.
- 4. We have seen firsthand that there are serious concerns surrounding the fidelity of many out-of-state programs. So much so, these students have been unable to attain the 486 endorsement through MDE because they have historically been unable to pass the SLLA. This clearly supports the notion that the candidates are ill-prepared to lead in our state.

Thank you for taking the time to review my concerns. I hope you will rethink the reversal of Miss. Admin. Code 7-4: Part 4: Licensure Guidelines K-12 since it would likely place incompetent leaders in our schools. The education system in Mississippi is on the move in the right direction. It would be unwise to take contrary action.
