<u>Background and Purpose</u>: Miss. Code Ann. § 37-3-82 established the Mississippi Community Oriented Policing Services in Schools (MCOPS) Grant program for the utilization of School Resource Officers (SRO) within the K-12 education system. The law allocates a minimum of \$10,000 per officer for Districts to pay for the salary and benefits of School Resource Officers. The funding must be matched from local funds on a 50/50 matching basis.

Award Amount: \$750,000.00

Method of Award: Request for Proposals
