Minutes of Mississippi Board of Education Meeting

May 18, 2023

The members of the Mississippi Board of Education met at 10:00 a.m. on Thursday, May 18, 2023, pursuant to Miss. Code Ann. § 25-41-5 for the purpose of conducting a regularly scheduled Board meeting.

The public accessed this meeting via livestream or in-person at the Central High School Building, 4th Floor Boardroom, 359 North West Street, Jackson, Mississippi. Board members physically present included: Dr. Wendi Barrett, Mr. Glen V. East, Mr. Bill Jacobs, Dr. Ronnie L. McGehee, and Mr. Matt Miller. Board member participating virtually: Ms. Mary Werner (Saltillo, Mississippi). Student Representative present: Mr. Charlie Frugé. Mr. Michael D. Kent, Interim State Superintendent, was also present.

- I. Mr. Glen V. East called the Board meeting to order at 10:00 a.m., after determining that a quorum of the Board existed for the purpose of conducting a meeting.
- II. Mr. Bill Jacobs led the Pledge of Allegiance and Mr. Matt Miller gave the Invocation.
- III. On a motion by Dr. Ronnie L. McGehee, seconded by Mr. Bill Jacobs, the Board unanimously approved the minutes of April 19, 2023, Board meeting and the minutes of Special-Called Board meeting on April 19, 2023.
- IV. On a motion by Mr. Bill Jacobs, seconded by Mr. Matt Miller, the Board unanimously adopted the Consent agenda.
 - On a motion by Dr. Ronnie L. McGehee, seconded by Mr. Matt Miller, the Board approved the agenda as presented.

- VI. Mr. Michael D. Kent gave the following report as the Interim State Superintendent of Education:
 - Mr. Kent stated he spent most of the month traveling the state for the Regional Superintendents meetings at each of the state's six Regional Education Service Agency (RESAs).

- Mr. Kent stated that during the meetings with superintendents, staff had some discussions with superintendents about what degree of change, if any, was needed to the Statewide Accountability System.
- Mr. Kent stated that he tasked the RESA directors with conducting very focused discussions with superintendents during their RESA meetings about specific areas where the accountability system can be improved or strengthened. Mr. Kent stated that Dr. Paula Vanderford will be following up with the RESA directors with additional instructions.
- Mr. Kent stated that another issue emerged during the Regional Superintendents meetings involving the annual single audits that districts are required to submit to the Office of the State Auditor. Mr. Kent stated many districts are having trouble getting their audits completed within state and federal deadlines because there is a limited pool of state auditor approved CPAs available to complete the audits. Mr. Kent stated his intention is to recommend to the Commission of School Accreditation and then to the State Board a temporary relief from MDE's sanctions related to these late audits. Mr. Kent stated that MDE's sanctions stem from federal law and requirements from the State Auditor, which are beyond our authority to change. Mr. Kent stated he is requesting a meeting with the State Auditor in the upcoming weeks to discuss this issue.
- Mr. Kent stated that MDE has continued to work with the Legislature to finalize the calculation for allocating the \$100 million the Legislature appropriated for districts based on average daily enrollment. Mr. Kent stated this process has been illuminating because it has tested some assumptions about whether average enrollment is higher during months 2 and 3 of the school year or whether it is higher when you take the average across months 1 through 8 of the school year. Mr. Kent stated MDE has performed several calculations and conducted state- and district-level analyses of various scenarios and found the difference in enrollment between months 2 and 3 and months 1 through 8 to be 7/10 of one percent. Mr. Kent stated that MDE will send allocations to districts once we receive approval of the calculation from the Legislative Budget Office (LBO).
- Mr. Kent stated he was privileged to take part in the announcement and celebration of the 2023 Mississippi Teacher of the Year and Administrator of the Year. Mr. Kent stated that the Teacher of the Year is Louise Smith of Gautier Middle School, and the Administrator of the Year is Dr. Caterria Payton, Principal at Pascagoula High School. Mr. Kent stated that both recipients are in the Pascagoula-Gautier School District. Mr. Kent stated that he was extremely impressed by these two educators and all the honorees in attendance.
- VII. Mr. Glen V. East, Acting Chair of the State Board, gave the following report:

Mr. Glen V. East, Chair of the Academic Achievement PreK-12/Early Childhood Subcommittee, reported they met yesterday, and discussed the grants for the summer reading camps that will be presented to the Board today.

Mr. Bill Jacobs, Chair of the Legislative Subcommittee, reported they met today, and discussed some meetings that have been held recently with members of the Legislature regarding the upcoming search for the State Superintendent.

Dr. Ronnie L. McGehee, Chair of the School Performance and Accountability Subcommittee, reported they met today. Dr. McGehee stated he, Mr. Bill Jacobs, and Ms. Mary Werner met on May 11-12, 2023, for interviews of the 12 semifinalists to choose four finalists. Dr. McGehee announced that the four finalists are: Yaerim Choi, Starkville-Oktibbeha Consolidated School District, Starkville High School; Kate Riddle, Lafayette County School District, Lafayette High School; Alex Ritchie, Oxford School District, Oxford High School; and Grace Taylor, Rankin County School District, Northwest Rankin High School. Dr. McGehee stated the four finalists will be interviewed by the State Board on June 14, 2023, at 8:30 a.m. where a student representative will be chosen along with one alternate.
