Indianapolis, Indiana

Scope of Project: Under the original terms and conditions, OTSS request approval to modify contract with Guidesoft to extend services for 17 additional months. This will allow the Office of Technology and Strategic Services to continue information technology professional services for the maintenance and support of the Mississippi Student Information System (MSIS 2.0). Maintenance and support activities will include enhancements, bug-fixes and addressing new requirements from school districts and program offices to ensure proper performance of MSIS 2.0 over the duration of the contract. The total sum compensation to be paid under this contract shall not exceed the specified sum of \$22,686,300.

Personnel associated with this contract are not former Department employees or related to any Department employees.
