04. Action: Approval as required by Mississippi Code Ann. § 37-153-15, the enclosed list of qualifying industry certification as approved by the State Workforce Investment Board [Goal 2 – MBE Strategic Plan]

<u>Background Information</u>: As required by Miss. Code Ann. § 37-153-15 the State Workforce Investment Board shall provide the State Board of Education annually with a list of qualifying industry certifications that fit the following criteria:

- Require, on average, less than a college education
- Align with the five Workforce Innovation and Opportunity (WIOA) State Plan approved sectors
- Have an average annual wage within 70% of the state average
- Have at least one qualifying industry certification
- Have job demand in the state

Beginning in fiscal year 2019-2020 and subject to available funding, the Department of Education shall pay a career and technical education incentive grant to the public school for each student enrolled in the public school who earns a qualifying industry certification. The amount per student for the career and technical education incentive grant shall be Six Hundred Dollars (\$600.00). If the statewide sum of the grants exceeds the amount appropriated, the grants per student shall be reduced proportionately to cover all eligible grants.
