Executive Summary

The Mississippi Secondary Curriculum Frameworks have a four-year curricula revision cycle. The revision cycle includes input from local district personnel and business/industry partners. Approved secondary curricula will be disseminated for implementation in the 2020-2021 school year.

2020 Business, Marketing, and Finance

- Aligned new curriculum with 2018 Mississippi College- and Career-Ready Standards (MCCRS) for Economics, International Standards for Technology in Education (ISTE) standards, Framework for 21st Century Learning standards, Entrepreneurship and Small Business (ESB) objectives, and the National Business Education Association standards.
- “Enrichment” section added to some units. This material is not tested, but enhances the other material in the unit.
