L. Approval to revise Process Standard 24 in Miss. Admin Code: 7-24, Mississippi Public School Accountability Standards, 2020 and Process Standard 20 in Miss. Admin Code: 7-163, Mississippi Nonpublic School Accountability Standards, 2020 (Has cleared the Administrative Procedures Act process with public comments)

<u>Background Information</u>: The proposed revisions to the process standards will provide clarity to the existing standards regarding the requirement for districts to provide planning time for full-time classroom teachers.

The Commission on School Accreditation (CSA) met on Thursday, October 1, 2020 during a regularly scheduled meeting and voted unanimously to submit a request to the State Board of Education to begin the APA process to approve the proposed revisions to Process Standard 24 of the *Mississippi Public School Accountability Standards*, 2020. (Process Standard 20 of the *Mississippi Nonpublic School Accountability Standards*, 2020 corresponds with Process Standards 24 of the *Mississippi Public School Accountability Standards*, 2020.)

The Office of Accreditation received the following comments regarding the proposed revisions to the process standards that will provide clarity to the existing standards for the requirement for districts to provide planning time for full-time classroom teachers.

Even though the intent is good to ensure that CTE has a "required" planning period. The reason that CTE teachers were left out of this standard was to give Centers the flexibility for unusual situations where a need might arise for flexible class loads, etc Alternate wording: "Each full-time classroom teacher has an unencumbered period during the teaching day/week to be used for individual or departmental planningwith the exception that an unencumbered period for career and technical education teachers is strongly encouraged but would be left up to the discretion of the Career and Technical Education Director." This would allow CTE schedules, within reason, to be more flexible than academic and allow for Center discretion.	No Change. Although the need for flexibility is recognized the intent of the change was to ensure that all teachers receive an appropriate amount of planning time to ensure sound lessons, student interventions, etc.
The corrections/modifications are acceptable. However, one point to mention, it is not logical to have a different number of minutes for planning for elementary and secondary instructors. I realize this is how it has always been done, but with the instruction that is required for the lower grades, coupled with a higher percentage of elementary teachers as compared to secondary teachers who are teaching subjects/students who are taking the state assessments.
