Minutes of Mississippi Board of Education Meeting

March 26, 2020

The members of the Mississippi Board of Education met in a special-called Board meeing at 10:00 a.m. on Thursday, March 26, 2020, via teleconference pursuant to Miss. Code Ann. § 25-41-5 for the purpose of discussing any waivers/suspensions of statutes and/or rules and regulations as a result of the impact of COVID-19 (coronavirus).

The location of the meeting available to the public was by live stream and audio recording. Board members present included: Ms. Rosemary G. Aultman (Clinton, Mississippi), Mr. Buddy Bailey (Brandon, Mississippi), Senator Nancy Collins (Tupelo, Mississippi), Dr. Jason S. Dean (Madison, Mississippi), Dr. Karen J. Elam (Oxford, Mississippi), Dr. John R. Kelly (Gulfport, Mississippi), Ms. Brittney Rye (Starkville, Mississippi), Mr. Sean Suggs (Saltillo, Mississippi), Mr. Omar Jamil (Southaven, Mississippi) and Ms. Shelby Dean (Clinton, Mississippi). Dr. Carey M. Wright was also present at Madison, Mississippi to participate in this teleconference meeting.

- Dr. Jason S. Dean, Chair, called the special-called Board meeting to order at 10:02 a.m. and stated that the meeting was being live streamed.
 - Dr. Dean noted that the meeting of the Board of Education was being held via teleconference pursuant to Miss. Code Ann. § 25-41-5 and the notice of this meeting included the date, time, place, and purpose of the meeting and identified the location the public could view the meeting. Dr. Dean stated that an audio recording was being made of the meeting and that a quorum of the Board existed at the locations stated for the purpose of conducting a meeting through teleconference means.
- II. Dr. Dean recognized the efforts by Dr. Carey M. Wright, the Executive Leadership Team, and the staff of the MDE working remotely for all their hard work for a whole new process of education that has not been done before. Dr. Dean stated he met with the task force to work with Governor Tate Reeves' request to keep education going either online or by other instructional methods. Dr. Dean stated they discussed Broadband and device availability, federal policies around E-rate, and some financial questions around dual enrollment and online classes, and shared ideas and thoughts from professionals that could be presented to the Governor in the future. Dr. Dean stated this would be a roadmap to the technical aspect of going online in the future.
- III. Dr. Carey M. Wright recognized the team at MDE for working non-stop to put together resources for districts. Dr. Wright stated hats off to the superintendents, principals, teachers, and support staff for working to make sure the students are fed and have the learning materials to continue their education. Dr. Wright stated she met with the Superintendent's Advisory Council yesterday via teleconference

and presented the information to them that the Board will review today and they were very appreciative of the materials to be presented. Dr. Wright stated that she assured them that the Board would come back together later if it is discovered that something needs to be addressed that is not covered today.
